This is a statement in connection with Part VII-B, Question 2(b), of the Amended Form 990-PF for tax year 2013 for the MerryMac McKinley Foundation, Inc. (the "Foundation"). The Foundation is amending Form 990-PF for 2013 to voluntarily disclose and correct errors made in prior years (1999 through 2014) related to the valuation of non-charitable use assets and the resulting understatements of undistributed income for those years. Certain other adjustments have been made to items of income and expenses as previously reported. Also, the Part V, Qualification Under Section 4940(e) for Reduced Tax on Net Investment Income, previous five-year data has been adjusted for the correct adjusted qualifying distributions and net value of non-charitable use assets that would have been reported had the Form 990-PF for each of those years also been amended.

**Facts and Circumstances.** In 2016, the Foundation discovered that there had been an error in the calculation of the average fair value of certain non-charitable use assets of the Foundation since the year 1999. The error resulted in the understatement of the average fair value for the years 1999 through 2014, and that understatement resulted in a shortfall in each of those years in the qualifying distributions made by the Foundation. The Foundation had employed and relied on qualified outside accountants for the calculations and the preparation of the returns during all years affected. However, when the math error was discovered by Foundation personnel, the Foundation immediately sought legal advice from attorneys familiar with private foundation tax regulations and also engaged tax compliance services from a certified public accountant with significant experience preparing Forms 990-PF.

The Foundation has corrected the undistributed income by making distributions in excess of the cumulative total undistributed amount to qualified public charities in calendar year 2016 to cover all cumulative undistributed amounts from all years affected, including years that are closed by the statute of limitations (1999-2012). The Foundation is treating such distributions as being made out of the undistributed income for the taxable years for which a tax would have been imposed. Although the closed year returns are not being amended, the Foundation has determined the proper adjustments (as if it had drafted revised returns for 1999 through 2012) to the qualifying distributions and fair value calculations in order to calculate the cumulative undistributed amounts for those years, and those undistributed amounts have been included to calculate the total aggregate shortfall that carries over to 2013. The first tax year that, upon correction, had a taxable undistributed amount was 2002. All of the cumulative undistributed amounts through 2012 have been stated in Part XIII, Line 2b, of the Amended Form 990-PF for 2013.

In addition to the Amended Form 990-PF for 2013, please refer to the Amended Form 990-PF for 2014 and the Form 990-PF for 2015. The Foundation will also be filing a Form 4720, Return of Certain Excise Taxes, for 2013, 2014, and 2015, and a request for abatement under Section 4962 of the Internal Revenue Code of 1986, as amended (the "Code").

The remainder of this statement will show that the Foundation meets the reasonable cause exception under Code Section 4942(a)(2) and that no tax should be imposed with respect to the undistributed amounts.

Exception Under Code Section 4942(a)(2). Code Section 4942(a)(2) provides that no tax will be imposed on a foundation with respect to the undistributed amount if the following requirements are met:

- (1) The failure to distribute resulted solely from an incorrect valuation of assets;
- (2) the improper valuation was not willful and was due to reasonable cause;
- (3) the foundation makes the qualifying distributions of the amount during the "allowable distribution period" – this is the period beginning with the first day of the first tax year following the tax year in which the incorrect valuation occurred and ending 90 days after the mailing of a notice of deficiency with respect to the initial tax extended by (a) the period during which a deficiency cannot be assessed because a Tax Court petition was filed, and (b) any other period which the Internal Revenue Service ("the Service") determines is reasonable and necessary to permit a distribution;
- (4) the foundation notifies the Service that the amount has been distributed to correct the failure; and

(5) the foundation elects to treat the distributions as made from the undistributed income of the particular tax year for which a tax would have been imposed were it not for this relief provision (i.e., the year in which it made the valuation error).<sup>1</sup>

1. Failure to Distribute Resulted Solely From An Incorrect Valuation of Assets. First, the failure to distribute such amounts in the prior tax years resulted solely from an incorrect valuation of assets. As described above, the Foundation's outside accountants made a calculation error in the calculation of the average fair value of certain non-charitable use assets. The error resulted in the understatement of the average fair value for the years 1999 through 2014, and that understatement resulted in a shortfall in each of those years in the qualifying distributions made by the Foundation.

The Foundation's assets are held and managed by several different investment management firms. As such, an outside accountant created a spreadsheet in order to consolidate and track the investment assets of the Foundation as a whole. The spreadsheet reflected the average fair market value account balances by investment managers and type of security held on a monthly basis. The columns for the year were then totaled and divided by twelve months to compute the average annual account balances. The same spreadsheet format was used from 1999 through 2014.

However, there is one mutual fund investment manager that reports to the Foundation on a quarterly basis rather than on a monthly basis. It was in this account that the average annual fair market value account balance was miscalculated. The miscalculation was due to a formula error in the spreadsheet. When computing the average fair market of assets of this investment manager, the four quarterly values for this account were mistakenly divided by twelve rather than four (most likely caused by copying the formula in the adjacent cell of the spreadsheet). As a result, the fair market value balance for the account was understated by sixty-seven percent. The spreadsheet historically had also been reviewed annually by another qualified accountant who prepared the Foundation's tax returns.

2. Not Willful and Due to Reasonable Cause. Second, this incorrect valuation was not willful and was due to reasonable cause. The terms "willful" or "willful neglect" and "reasonable cause" are not defined in either Code Section 4942 or Code Section 4962 (relating to the request for the abatement of certain taxes, including the excise tax imposed on failure to distribute the required amount under Code Section 4942), but certain Treasury Regulations, case law, and other published guidance offer clarity regarding these terms.

In general, "willful" means "voluntary, conscious, and intentional,"<sup>2</sup> and no motive is necessary to make an act (or failure to act) to avoid the legal restrictions on a foundation or the occurrence of any tax willful.<sup>3</sup> Treasury Regulation Section 1.507-1(c)(5) further provides that a foundation's act (or failure to act) is not willful if the foundation (or foundation manager) does not know that it is an act (or failure to act) to which Chapter 42 of the Code applies. The United States Supreme Court has described "willful neglect" as meaning a "conscious, intentional

failure or reckless indifference.”<sup>4</sup> The Service has also noted that willful neglect implies a “voluntary, conscious, and intentional failure to exercise the care that a reasonable person would observe under the circumstances to see that the standards were observed, despite knowledge of the standards or rules in question.”<sup>5</sup> If it is determined that a violation was caused by willful neglect, such a determination will prevent abatement of the first-tier tax under Code Section 4962, but the lack of willful neglect would not, in itself, justify abatement, as the taxpayer must also prove there was reasonable cause.<sup>6</sup>

In particular, Treasury Regulation Section 53.4942(a)-1(b)(2) indicates that a valuation mistake is not willful and is due to reasonable cause, if, under all the facts and circumstances, the foundation made all reasonable efforts in good faith to value the assets under the rules described in paragraph (c)(4) of Treasury Regulation Section 53.4942(a)-2.<sup>7</sup> A foundation ordinarily meets this standard if it obtained a bona fide appraisal by a qualified appraiser (regardless whether this person is a disqualified person with respect to the foundation), the foundation fully disclosed the relevant facts to the appraiser, and the foundation relied on the appraisal.<sup>8</sup> However, a foundation’s failure to obtain an appraisal is not evidence that a valuation error is without reasonable cause.<sup>9</sup>

Treasury Regulations under other Chapter 42 Code sections reflect that a reasonable cause standard is “ordinary business care and prudence.”<sup>10</sup> Certain cases have defined “reasonable cause” in a similar fashion in the context of other taxpayers.<sup>11</sup> In addition, if a taxpayer relies in good faith on the advice of counsel or a qualified tax professional, such reliance may establish reasonable cause and show an absence of willful neglect. When a taxpayer engages a competent tax professional, provides the professional with all necessary information, and requests the professional to make a determination on a tax matter or prepare tax returns, the taxpayer meets the reasonable cause standard, by doing “all that ordinary business care and prudence can reasonably demand.”<sup>12</sup> It is a generally accepted principle that the reliance on the advice of counsel or expert accountants, when it is sought and received in good faith, is reasonable cause in certain circumstances.<sup>13</sup>

As an example, in the *Haywood Lumber* case, the taxpayer, a personal holding company, consulted a certified public accountant (“CPA”) who was competent to advise on tax matters to prepare the proper corporate tax returns.<sup>14</sup> The taxpayer disclosed to the CPA all necessary

information about the company.<sup>15</sup> The taxpayer was not aware that it was in fact a personal holding company, and although the CPA was aware of this fact, he did not prepare a personal holding company surtax return for the taxpayer.<sup>16</sup> The taxpayer filed only the returns prepared by the CPA.<sup>17</sup> The Tax Court held that because the taxpayer had not specifically inquired of the CPA about the personal holding return, but rather “awaited passively,” he had not shown ordinary business care and prudence.<sup>18</sup> The Court of Appeals reversed the opinion of the Tax Court, holding that the taxpayer had in fact shown reasonable cause in failing to file the proper tax returns, when he relied on the advice of a CPA competent to advise on tax matters.<sup>19</sup>

In the *Boyle* case, the United States Supreme Court affirmed the precedent (including *Haywood Lumber*) which had established that relying on counsel or tax professionals for substantive questions of law does constitute “ordinary business care and prudence,” and thus, reasonable cause.<sup>20</sup>

In Technical Advice Memorandum 201423035,<sup>21</sup> the Trustee of a trust consulted a tax preparer that held himself out as an expert authorized to practice before the Service.<sup>22</sup> The tax preparer mischaracterized the trust as a complex, taxable trust, rather than a non-exempt charitable trust subject to the private foundation provisions of Chapter 42 of the Code.<sup>23</sup> Relying on this advice, the Trustee made donations to the charitable beneficiaries of the trust, treating them as charitable deductions of a taxable trust, instead of qualifying distributions of a private foundation.<sup>24</sup> The amounts donated did not equal what would have been required distributed amounts of the private foundation over the years in question.<sup>25</sup> After examining the trust’s tax returns, the Service issued a “no-change” letter, stating that no change to the tax returns were necessary.<sup>26</sup> Subsequently, the charitable beneficiaries sued the Trustee and the trust, and the Trustee engaged a new accountant and new tax counsel, who informed the Trustee that the trust was actually a non-exempt charitable trust subject to the private foundation provisions.<sup>27</sup> To correct its failure, the Trustee filed Forms 990-PF with the Service, paid the excise tax and penalty for underpayment of estimated tax, plus interest.<sup>28</sup> The Trustee also made qualifying distributions of all remaining undistributed income for the years in question.<sup>29</sup> The Trustee then requested that the excise tax be abated under Code Section 4962, because the failure to distribute was due to reasonable cause and not willful neglect.<sup>30</sup>

The Service granted the abatement request after finding that under-distribution was properly corrected and the under-distribution was due to reasonable cause and not willful neglect.<sup>31</sup> The memorandum states that reasonable cause means “ordinary business care and prudence,” and that “when the taxpayer has obtained advice from a competent tax professional on the specific matter and the taxpayer has provided the advisor with all the necessary information, the taxpayer has exercised ordinary business care.”<sup>32</sup> In this case, the Service concluded that the Trustee showed ordinary business care and prudence by consulting the accountant and by following the instructions in the trust document in making the charitable donations, and the Trustee relied in good faith on the advice of the accountant.<sup>33</sup>

In the Foundation’s case, the Foundation’s failure to distribute the required amounts was due to reasonable cause and was not willful. There was no voluntary, conscious, and intentional decision on the part of the Foundation to fail to make the proper distributions; the Foundation sought to exercise the care that a reasonable person would observe. The Foundation exercised ordinary business care and prudence by engaging qualified outside tax accountants to prepare the Foundation’s tax returns, calculate the Foundation’s net asset value, and advise the Foundation on its required minimum distributions. After fully disclosing all of its assets and relevant information to the accountants, the Foundation relied on the accountants to calculate its net asset value and the minimum required distribution amount each year and to prepare its tax returns in accordance with applicable law. The Foundation relied on the accountants to use commonly accepted appraisal methods in valuing the Foundation’s assets, as described in Treasury Regulation Section 53.4942(a)-2(c)(4); however, error in the formula calculation in the spreadsheet (as described above) led to the incorrect valuation of assets. The Foundation believed in good faith that it was distributing the proper amounts for such tax years, since it did not discover the valuation error until 2016.

Like the taxpayers in the *Haywood Lumber* case and Technical Advice Memorandum 201423035, the Service should determine that there is no willful act or willful neglect on the part of the Foundation, and that the Foundation exercised ordinary business care and prudence to satisfy the standard for reasonable cause.

3. Qualifying Distributions Made During Allowable Distribution Period. Third, the Foundation has made qualifying distributions in excess of the cumulative total undistributed amount to qualified public charities in calendar year 2016, which is during the allowable distribution period, to cover all cumulative undistributed amounts from all years affected, including years that are closed by the statute of limitations (1999-2012). Although the failure to distribute relates back to the tax year 1999, the Foundation only discovered the valuation error in 2016, and the Foundation has not yet been notified of a deficiency by the Service with respect to the initial tax, so the Foundation has made the distributions during the allowable distribution period.

4. Notice to the Service Regarding Distributions Made. Fourth, by this statement, the Foundation hereby notifies the Service that the Foundation has made the qualifying distributions to qualified public charities in calendar year 2016 to cover all cumulative undistributed amounts

from all years affected, including the closed years. Because there is no separate form to notify the Service of this matter, this statement included with the Foundation's Amended Form 990-PF for 2013 should properly suffice for this requirement.

5. Election to Treat Distributions As Made from Undistributed Income of Relevant Tax Years. Finally, the Foundation has elected to treat the distributions as made from the undistributed income of the particular tax year for which a tax would have been imposed were it not for this relief provision (i.e., the year of the valuation error).

Under General Counsel Memorandum 39808, the Service concluded that it could make certain adjustments to years closed by the statute of limitations.<sup>34</sup> In the memorandum, a private foundation incorrectly computed its minimum investment return and understated its required distributable amount for 1982.<sup>35</sup> The private foundation's qualifying distributions for that year were greater than the required distributed amount (as incorrectly calculated), and thus, the private foundation took an excess distribution carryover which it applied in 1986.<sup>36</sup> After examining the 1986 return, the Service recognized that the error occurred in 1982, a year which was closed for purposes of the statute of limitations.<sup>37</sup> The Service determined that it could adjust the excess distribution carryover for a year not barred by the statute of limitations (1986) by recalculating the distributable amount of amount of qualifying distributions for closed years.<sup>38</sup> The Service cited several cases dealing with net operating loss carryovers to establish the general principle that, while it cannot recalculate the investment income and impose an excise tax for a closed year, it can recalculate the distributable amount and the amount of qualifying distributions for a closed year, and reapply (or disallow) any excess carryovers in an open year.<sup>39</sup>

In the Foundation's case, the valuation error applied to tax years 1999-2014. Although the Foundation is not filing amended tax returns for 1999-2012 (the closed years), the Foundation has determined the proper adjustments (as if it had drafted revised returns for 1999 through 2012) to qualifying distributions and fair value calculations in order to arrive at the cumulative undistributed amounts and to achieve the correct carryovers to 2013. The first tax year that, upon correction, had a taxable undistributed amount was 2002. All of the cumulative undistributed amounts prior to 2012 have been stated in Part XIII, Line 2b, of the Amended Form 990-PF for 2013, and a summary was provided on pages 1 and 2 of this statement.

As a part of revising the calculations for the closed years, the Foundation determined that it had excess distributions available in two years. The Foundation determined to make the election to treat current year qualifying distributions in excess of the immediately preceding tax year's undistributed income as being made out of the undistributed income for prior years. The Foundation reviewed the oldest year first and made the following determinations. The elections made virtually on the amended returns were as follows (see following pages).

Because qualifying distributions in 2014 were not sufficient to exhaust the undistributed income for the prior year, no Code Section 4942(h)(2) election can be made; there are no excess distributions available to apply to any prior year. As a result, the Amended Form 990-PF for 2014 creates a new undistributed amount of \$42,319.

As of the date of this filing, the Foundation has distributed amounts in excess of \$135,928 (the cumulative total undistributed amount as of the end of 2015) to qualified charities. The Foundation is treating such distributions as being made out of the undistributed income for the taxable years for which a tax would have been imposed. In addition, the Foundation will distribute at least \$109,157 to qualified charities prior to December 31, 2016 (which reflects the undistributed income for 2015). In total, the Foundation will distribute at least \$245,085 to qualified charities by December 31, 2016. In addition to the Amended Form 990-PF for 2013, please refer to the Amended Form 990-PF for 2014 and the Form 990-PF for 2015.

Conclusion. For the reasons set forth above, the Foundation has complied with the requirements of Code Section 4942(a)(2)(B), (C), and (D), and requests that no tax be imposed on its failure to distribute the required amounts.
