2. *Applicant must be a customer of Copper Valley Telephone or a minor child or legal dependent of a customer of the Copper Valley Telephone (Dependents must have been claimed on the member's last tax return)*
3. *Applicant must be in the graduating class of, or have graduated from, an accredited public, parochial or private high school or must have obtained a G.E.D. Applicant must have plans to enter, or presently be enrolled in a college, university, trade, technical or business school for the next year.*
