THE FOUNDATION SEEKS TO PROVIDE FUNDING FOR WACO ISD TEACHERS AND SCHOOLS BY AWARDING GRANTS IN FOUR FOCUS AREAS: EARLY CHILDHOOD DEVELOPMENT, ENHANCED PROGRAMMING FOR ADVANCED STUDENTS, EXTENDED EDUCATION FOR STAFF, AND EMPHASIS ON STUDENT PERFORMANCE. TO DATE, THE FOUNDATION HAS AWARDED OVER \$1,100,000 IN 352 GRANTS TO WISD TEACHERS.
