CHARITABLE GIVING: 501 (c) (3) organizations operating in each of Grande Communications' markets (all within Texas) are invited to submit grant applications to the Grande Cares committee in each market. Based on the grant money allocated to each market each quarter, the market-level committee decides which organizations they would like to give to. Their recommendations are then voted on by the entire Grande Cares board of directors each quarter. In 2013, seventy-two grants were approved for an average grant amount of \$1,776. The applications ask the organization to describe their mission or purpose and their target beneficiaries. Typically, the local committee makes a visit to the organization to see first-hand how the group operates. The number of grants per market in 2013 were Austin (12), San Antonio (14), Dallas (7), Waco (11), Midland/Odessa (5), Corpus Christi (10), and San Marcos (13).

VALUED VOLUNTEER GRANTS: Grande Cares members can donate their time to local non-profit organizations and after they accumulate a certain amount of hours, the member can request either \$200 or \$400 be paid to the non-profit organization. In 2013, thirty-eight valued volunteer grants were approved for an average grant amount of \$542. The average grant was skewed higher because a group of San Antonio members banded together for a project at Boys Town Texas where they worked over several weeks to refurbish the organization's playground area. This group of members earned an \$8,600 grant to Boys Town Texas.

GRANDE EMPLOYEE MEMORIAL SCHOLARSHIP GRANTS: Each year, the Grande Cares organization awards scholarships to one or more students for their post-secondary education. Potential scholarship awardees are asked to complete an application which is reviewed and voted on by a scholarship subcommittee of Grande Cares. In 2013, four scholarships were awarded for an average amount of \$1,163.

For charitable giving grants to 501 (c) (3) organizations, Grande Community Chest does up front due diligence in the form of application review, phone calls, and on-site visits to view the operations and learn more about the organization's purpose and mission.

For valued volunteer grants, Grande Community Chest reviews the form submitted by the member which is signed by the non-profit organization. No research is conducted into the organization.
