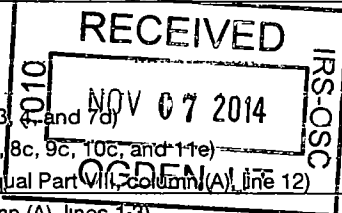

THE MIRACLE FOUNDATION IS AN ESTABLISHED AND TRUSTED MULTINATIONAL NONPROFIT ORGANIZATION. WE BELIEVE CHILDREN CAN - AND SHOULD - BE LIFTED OUT OF THE CYCLE OF POVERTY. AND WE BELIEVE IN HELPING PEOPLE HELP THEMSELVES. WE PARTNER WITH STRUGGLING ORPHANAGES WITH A LOT OF HEART, BUT NOT ENOUGH RESOURCES TO FEED, CLOTHE, NOURISH AND EDUCATE THEIR CHILDREN. THROUGH YEARS OF EXPERIENCE, WE HAVE FOUND THAT THE MOST SUSTAINABLE WAY TO HELP PEOPLE HELP THEMSELVES IS TO STRENGTHEN EXISTING ORPHANAGES AND TRANSFORM THEM INTO LOVING HOMES WHERE CHILDREN CAN THRIVE. THIS APPROACH EMPOWERS CAREGIVERS AND EMPOWERS ORPHANS. ITS TRANSFORMING. ITS MEASURABLE. ITS PROVEN. ITS SCALABLE. AND ITS THE RIGHT THING TO DO.

BY USING A CLUSTER APPROACH IN ORDER TO EXPAND, WE WERE ABLE TO CREATE HUBS IN THE NORTHERN, WESTERN, AND SOUTHERN REGIONS OF INDIA. THE MIRACLE FOUNDATION ORGANIZED AND LED 4 TRIPS TO INDIA AND TOOK 60 TRAVELERS TO MEET OUR CHILDREN AND SEE 3 ORPHANAGES FIRST HAND. WE BROUGHT A CHILD-FRIENDLY LIBRARY TO A CHILDRENS HOME WITH OVER 100 BOOKS FOR VARIOUS READING LEVELS, COLORFUL MURALS, AND STUFFED ANIMALS. OUR FIRST 2 CHILDREN GRADUATED HIGH SCHOOL, PURSUED HIGHER EDUCATION AND CONTINUE TO WORK HARD TO REACH THEIR FULL POTENTIAL. THROUGH IMPLEMENTATION OF OUR SYSTEMATIC METHOD, THE MIRACLE FOUNDATION CONTINUED TO PROVIDE ORPHANS WITH THE MOST FUNDAMENTAL RIGHTS AND UTMOST CARE.
