 Junia Company is a faith-based, non-profit personal development company focused on restoring and empowering vision for life! Our primary work is with women preparing them to transition from the back streets to the board rooms of churches, social service organizations, and businesses. We offer practical, unique, life-enriching services that are effective and challenging for those who want to change and fulfill destiny.

28 We served 597 women this year through Junia ministry, programs and curriculum. We served 17 homeless women who came through Ann's House this year for short or long term stays. Sixty-eight percent of the women who came to us learned how to get needed services, budget their money, and found a job or home. The majority of our residents found work within 30-45 days of entry into Ann's House. In addition, homeless women from other shelters and transition homes were ministered to through our "Thriving in Life" curriculum which teaches 55 key life skills to help them thrive and not just survive.
