

Church partnerships are essential to Love INC, and volunteers are its lifeblood. Many churches demonstrated their commitment by:

- * Hosting GAP Ministries.
- * Referring requests for help to our Clearinghouse.
- * Organizing church members to serve using their gifts and abilities.
- * Accepting referrals for help from the Love INC Clearinghouse to existing ministries.
- * Providing Clearinghouse volunteers from their church each year.
- * Praying for Love INC, clients, and the community.

Last year, church volunteers served our clients by providing transportation to appointments; fixing homes in disrepair; cleaning up yards and moving furniture for the elderly; fixing cars; handcrafting scarves, hats, blankets and pillow cases; and delivering "Baskets of Blessings" for Christmas. We continued our partnership in training with the New Hope Budgeting Program in Nampa to aid us in the future development of relational ministry in Boise.

In addition to direct Client Services, we strive for good stewardship in the day-to-day operations of our office. We are blessed to have donate space for our offices, utilities and our off-site GAP Ministries valued at \$54,000. We also received donated accounting and CPA services saving us over \$8800. With the hours, services and goods provided, we recorded ministry value of \$202,620 to families in the Boise Community; a value of \$2.59 for every \$1 cash donation.
