Group Residence Program - 97 homeless single parent women, children and older adults were welcomed into our shelter facilities In addition to the direct housing service, we provided case management, money management, mental health counseling, medical services, employment coach services, and programs and activities for the children Clients have access to computer lab, food pantry, and monthly weekend activities In 2013, over 80% of our single parent families secured employment which led to permanent housing placement 90% of the seniors/older adults secured permanent housing

Destination Home - A new service as part of a contract beginning in December 2012 and ending in September 2014 with a partnership between city of dallas and Dallas Housing Authority The goal of the program is to provide rapid rehousing to homeless families and homeless senior citizens and disabled individuals using DHA apartments By the end of 2013, we had met our goals for the first year - we assisted 20 homeless families and 15 senior citizens/disabled individuals The family count includes 20 adults and a total of 138 children Case management is provided to all adults As with our other programs, we coordinated special events and invited the families to our ongoing services and programs Clients have access to our food pantry, computer lab, donation room of clothes, shoes, etc Once a quarter (though it only happened twice in 2013) we provided specific activities at the properties Neighbor Night an evening of fun, food and learning about our services and commitment 45% of the clients who were assisted during the first year (2013) secured employment, 30% began to repair credit issues, and 15% of the adult clients enrolled in trade/vocational school or junior college

Homeshare - 192 individuals were assisted through our oldest housing service 98 elderly homeowners and 94 roommates Approximately 32 of the roommates were homeless and therefore received rental support through the Homeshare CARE program In addition to the direct housing, we provide case management, and access to our food pantry, donation of clothes, computer lab to assist with employment search and quarterly educational classes In 2013, over 60% of our clients secured permanent housing placement either by staying with the roommate or by our assistance in identifying new housing
