This year 542 bats were rescued while another 487 were released.We also began construction of a 7,200 sq ft new facility that will expand our capacity for rescuing and rehabilitating bats. We collaborated with the US Fish and Wildlife Service on efforts to control White Nose Syndrome. We assisted the International Fund for Animal Welfare and the Global Federation of Animal Sanctuaries in creating online resources for sanctuaries to instantly access life-saving care information for bats.**4 b** (Code: ) (Expenses \$ 48,979. including grants of \$ 0.) (Revenue \$ 81,268.)Bat World Sanctuary engages in raising the awareness of the public through speaking engagements, publications and promotional items showing bats in a positive context, and online communication about bats through our website and facebook page. We collaborated with Aperture Films to create an echolocation video for the National Park Service.
