**HIV Testing Program - A total of 631 HIV tests were conducted for individuals at high risk of HIV infection. Of these, 7 were newly diagnosed as HIV positive and referred to HIV primary care services.**

**HIV Prevention Programming for individuals at high risk for HIV transmission.**

**POL Program is a two session intervention for MSMs that is listed as an evidence based intervention by the CDC. A total of 70 participants completed the POL program in 2013 and conducted 982 peer led risk reduction conversations.**

**Condom Distribution - Distribute free condoms at times and in places where individuals at risk for HIV and other STIs will be reached. In 2013 a total of 74,319 condoms were distributed to 222 locations in Tarrant County.**

**Community Mobilization - The CM program is designed to expand the scope and reach of HIV prevention activities in North Texas. 71 individuals representing 42 organization joined the CM committee in 2013. A total of 9,066 HIV prevention contacts were made through CM led/sponsored activities.**
