Project Green Challenge. A powerful and diverse call to action to raise awareness about conscious living, informed consumption, and the collective impact of individual actions. Through 30-days of environmentally themed challenges, PGC provides college students globally with mentorship, advocacy, and leadership skills. Over its 4-year history this initiative has impacted approximately 15,000 students on 1,000+ campuses in 45 countries directly and 22.1 million around the world indirectly. PGC 2013 engaged close to 2,800 students representing 407 campuses in 50 states, and 30 countries. With this initiative as an impetus, powerful, dynamic, and passionate young eco leaders are emerging worldwide.

Conscious College Road Tour. A six-week fly/drive university tour to inform, inspire and mobilize students to transition their lives and school campuses from conventional to conscious. Each stop features a robust tabling event and a Town Hall meeting to kick start a sustainability project on each campus. Schools can fill out an application to have the organization visit their campus.

Conscious Kitchen. The Conscious Kitchen was founded to rethink school food systems based on six foundational terms: fresh, local, organic, seasonal, non-GMO, and zero waste. A holistic approach to school meals unites a diverse community of stakeholders working toward a common goal: nourishing students, while educating school communities about conscious choices through principles of gardening, nutrition, and cooking. Since its launch in August 2013, the program has set out to break the cycle of pre-packaged, heat and serve, overly processed food, typical of school dining. After one year at Bayside MLK Academy in Marin City, California, the CK has established a framework for systemic change, with scratch-cooked meals, hands-on gardening, nutrition and cooking education at the core. With wisdom and skills, these students are establishing themselves as informed, inspired, and mobilized global citizens.
