

Part II, Section 17a. In 2013, Alfanar, Inc., US secured 27.36% public support (23.32% in 2012), thus meeting the 10% threshold and moving closer to the 33 1/3% test. In 2013, to prepare for expansion of the Board, Alfanar, Inc., US strengthened its governance practices and risk and compliance procedures by approving the following: Director job descriptions, Director term limits as well as policies related to conflict of interest, document retention, anti-money laundering, and whistle blowing. Alfanar Inc., US worked with its sister charity Alfanar to extend its UK trademark for "Alfanar" through the World Intellectual Property Organization (WIPO) to the U.S. Patent and Trademark Office. Alfanar, Inc., US engaged New York-based fundraising consultant Timothy Runion [NY Charities Bureau ID # 32-67-06] to help the charity professionalise and enhance its fundraising efforts in the US. With Mr. Runion's support, funding proposals were developed and submitted to El Hibri Foundation and Deutsche Bank. Additionally, Mr. Runion compiled a list of prospective donors in the US for Alfanar, Inc., US to reach out to.

In 2013, Alfanar, Inc., US made grants amounting to \$140,000 (\$219,715 in 2012), which enabled Alfanar to expand its geographic and sector scope to support ambitious community-based organisations serving disadvantaged communities in Egypt and Lebanon to implement financially sustainable programmes in education and women's empowerment.

Alfanar, Inc., US provided Alfanar with \$140,000 to support general operations, monitoring and evaluation. These grants helped maintain Alfanar's teams in London, Cairo and Beirut, which provide critical venture philanthropy management support and technical assistance to all grassroots partners around strategic planning, budgeting, marketing and monitoring and evaluation. Alfanar, Inc., US support went to the following organisations:

In Egypt, the Bedayaat Foundation builds resiliency among street children at risk. Through Alfanar's support, Bedayaat has educated and empowered 115 street children living in the Badawi shelters in Minya City through reading, writing and basic math classes, 328 children through extracurricular arts programming and 717 adults and children through community-wide cultural activities. The Alfanar, Inc., US grant helped Bedayaat establish a children's center within the government shelters. The recent implementation of two income generating components within the shelters, including a weaving unit and a paper cone production unit, have led to restricted support from the Egypt-based company, SODIC.

In Lebanon, following a year-long process of scoping, proposal review, due diligence, and project design support, the Alfanar, Inc., US grant was used to support Ana Aqraa's innovative literacy intervention program that trains Lebanese public school teachers on the balanced literacy teaching approach. Ana Aqraa' (meaning "I can read" in Arabic) has taught 560 poor performers to read. The Nawaya Network in Lebanon provides at risk children with adult mentors who share similar interests. Inspired by "Big Brother, Big Sister" in the US, these meaningful mentorships help underprivileged youth develop their talents and access a path to success later in life.

Alfanar, Inc., US aims to secure increasing levels of public interest and support for Alfanar's ambitious venture philanthropy program.

These grants helped maintain Alfanar's teams in London, Cairo and Beirut, which provide critical venture philanthropy management support and technical assistance to all grassroots partners around strategic planning, budgeting, marketing and monitoring and evaluation. Specific support was provided to The Bedayaat Foundation (Egypt), Ana Aqraa' (Lebanon), and The Nawayya Network (Lebanon) through this grant.

In 2013, Alfanar, Inc., US grants made to Alfanar (charity registered in England and Wales No:1105048) helped develop and strengthen Alfanar's venture philanthropy portfolio and activities in Egypt and Lebanon where local teams were responsible for implementing Alfanar's activities including 1) assessing development needs, 2) administering grants to social purpose organisations selected through a structured screening process against approved criteria, 3) providing regular guidance to charity grantees to improve project design, implementation, and management systems, and 4) sourcing professional volunteer expertise to assist partners in overcoming specific management challenges, especially those related to achieving financial sustainability (For more detail see Schedule A)
