The Disciple Partners Transition Program provides housing, food, clothing, education and health care to help individuals with specified problems. Upon Graduation from the Alan & Ann Craft DoorWay Drug/Alcohol Recovery program, the men are eligible for our Disciple Partners Program, a low-income, transitional housing program for Open Door Mission graduates with no home or family waiting. The Disciple Partners receive transitional housing three months still at the Mission, three months in low-income housing, but still in the program - food and access to social services while they seek employment with the added help of job readiness preparation, job referrals, vocational training through our collaboration with Work Faith Connection, resume development and interviewing skills training. Disciple Partners continue recovery group participation, counseling and biofeedback. If the family is unable or unwilling to be reunited, the Mission assists the Disciple Partner to find long-term affordable housing. During 2013, the organization served up to 80 men per day.

**4b** (Code ) (Expenses \$ 223,072 including grants of \$ ) (Revenue \$ )

The Open Door Missions (ODM) Russell M. Scott Jr, M.D., Convalescent Care Center (RMSCCC) provides homeless men a safe, short-term environment to continue their convalescence from surgery, injury or illness. Frequently, homeless persons are discharged from hospitals with care instructions that are difficult to follow while living on the streets. Homelessness exacerbates health problems, complicates treatment and disrupts continuity of care. Homeless persons are 3 to 4 times more likely to die prematurely than are their housed counterparts. These deaths are most often associated with acute and chronic medical conditions which are exacerbated by life on the streets or in traditional shelter environments. The RMSCCC provides medical respite services to homeless men. Medical respite is a term used to describe recuperative or convalescent services needed by homeless people with medical problems. This service offers an alternative to discharging patients to the streets and allows for continuation of hospital-recommended care. During 2013, the organization served up to 31 men per day.

Open Door Missions DoorWay Drug and Alcohol Recovery Program employs a multi-level approach to drug and alcohol recovery. It's an intensive, 9-month, Christ-centered program designed to help students overcome drug and alcohol addictions. When men enter the program, they are involved in a comprehensive curriculum of self-discovery, life-skills, and spiritual renewal, and Bible study. They also participate actively in mentoring, counseling, and 12-step work. During 2013, the organization served up to 100 men per day.
