NOTES TO FINANCIAL STATEMENTS

December 31, 2013 and 2012

NOTE 1 - NATURE OF ORGANIZATION

The York Children's Foundation (the "Foundation") was organized by the York Group, Inc. ("York"), as a nonprofit Texas corporation. The Foundation was created for the purpose of providing financial support to nonprofit organizations and programs engaged primarily in benefitting the health, education, and welfare of children.

The Foundation has been determined to be a charitable private foundation by the Internal Revenue Service. Substantially, all of the Foundation's support is provided by York and the independent distributors of its products. All awards and grants are determined by the Foundation's Board of Trustees. A majority of the Trustees are comprised of persons who are not directly affiliated with York or its independent distributors.

In December 2001, York was acquired by Matthews International Corporation ("Matthews"), however, the Foundation is still administered by the Trustees.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of The York Children's Foundation, Inc. have been prepared on the accrual basis of accounting.

Income Taxes

The York Children's Foundation, Inc. is exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code and is classified as a private foundation. The tax returns of the Foundation are subject to examination by the regulatory agencies generally for three years after they were filed.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Cash and Cash Equivalents

The Foundation considers all highly liquid investments with an original maturity of three months or less to be cash equivalents. The Foundation has approximately \$2,000 in a money market mutual fund which is considered a cash equivalent.

Contributions

York and the independent distributors of its products make contributions to the Foundation based upon the products sold and registered with the Foundation. The Foundation also receives unsolicited contributions and memorial donations from York, the independent distributors, and outside parties. Contributions received are recorded as unrestricted, temporarily restricted, or permanently restricted support, depending on the existence and/or nature of any donor restrictions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Grants to other organizations

The Foundation makes contributions to not-for-profit organizations and programs engaged in benefitting the health, education, and welfare of children. The Foundation recognizes the expense in the period in which the Trustees approve the distributions of the grants.

Donated Services

The day-to-day operations of the Foundation are performed by employees of York and other unpaid volunteers. No amounts for these services have been reflected in the accompanying financial statements because the criteria for recognition of such effort under current accounting standards has not been satisfied.

Subsequent Events

Management has evaluated subsequent events through July 28, 2014, the date the financial statements were available to be issued.

NOTE 3 - TEMPORARILY RESTRICTED NET ASSETS

At December 31, 2013 and 2012, there are no temporarily restricted net assets.

NOTE 4 - PERMANENTLY RESTRICTED NET ASSETS

There were no permanently restricted net assets at December 31, 2013 and 2012.
