Grantmaker's Description of How Grants are Used	WEN awards five scholarships each year to five female graduating seniors who demonstrate an exemplary academic record and leadership skills. Scholarship candidates submit an application, including an essay where the applicants express their views on a current issue or event in the energy industry. These applications are reviewed by a scholarship selection committee who select the recipients based on the students' academic record, leadership initiatives, and quality of their essay. Each of the five scholarship award winners is granted a scholarship of \$2,000. The scholarship amount is held by WEN until the recipient begins college, which should be the fall following the year the scholarship was awarded. Each recipient is required to show proof of registration at their selected college. The award money of \$2,000 each is sent directly to the school financial office, in the student's name, to ensure it is used for its intended purpose of financial support for college. The scholarship application process is open to all female high school seniors in the greater Houston area. The scholarship is advertised on the WEN website and in the WEN newsletter.
