Amicus Association is a Texas non-profit corporation formed December 17, 2001, for the primary purpose of training gospel ministers for Spanish speaking people, with associated secondary ministries of medical care and livelihood training. Much of its work will be done in conjunction with the Baxter Superior Institute of Biblical and Cultural Studies and the James Moody Adams Clinic, both of which are ministries of Asociacion Amicus in Tegucigalpa, Honduras.

**ARTICLE ONE
OFFICES**

Section 1.01. The principal office of the corporation is currently located at the Westover Hills Church of Christ, 8332 Mesa Drive, Austin, Texas 78759. The corporation may have such other offices, either within or without the State of Texas, as the Board of Trustees may determine from time to time.

**ARTICLE TWO
BOARD OF TRUSTEES**

Section 2.01. **General Powers.** Subject to all limitations of the corporation's Certificate of Incorporation, of these Bylaws, and of applicable law and regulations, all powers of the Corporation shall be exercised by or under the authority of, and the business and affairs of the corporation shall be controlled by, a board of directors to be known as the Board of Trustees (the "Board"). The corporation has no members.

Section 2.02. **Number and Qualifications.** The number of Trustees shall be not less than five (5) or more than thirty-five (35). Each Trustee shall be of legal adult age, a person of responsibility, integrity, and high standing in the community in which he or she resides, committed to the mission and goals of the corporation, and an active Christian and member of a congregation of the churches of Christ.

Section 2.03. **Tenure of Office.**

(a) The Trustees shall be divided into six (6) classes of approximately equal numbers. The first class shall serve for a term of one year from the date of the first annual meeting following the adoption of these Bylaws. Successive classes shall serve for terms of two,

three, four, five, and six years from the date of the first annual meeting following the adoption of these Bylaws.

(b) The terms of not more than one-sixth plus two of the number of members of the Board of Trustees shall expire each year, and said members may be re-elected to the Board of Trustees. The persons selected as new Trustees shall be elected for a term of six (6) years, unless elected to fill the unexpired term of a Trustee who has resigned or been removed from office, or as may necessary to balance the six-year terms. All Trustees shall hold their offices until their successors have been elected in the manner provided herein. Trustees may serve successive terms without limitation.

(c) A Trustee shall be elected to the Board of Trustees only upon nomination by a member of the Board of Trustees followed by approval, with or without a meeting, of two-thirds ($2/3^{\text{rds}}$) of all the then serving Trustees (but excluding the Trustee being elected). The action of the Board of Trustees in approving or disapproving such a nomination shall be conclusive as to the qualifications or lack thereof of that person for membership on the Board of Trustees. All elections of Trustees shall be evidenced by a certificate signed by the Secretary of the Board of Trustees and filed with the minutes of the proceedings of the Board of Trustees.

Section 2.04. **Vacancies**. Any vacancy occurring in the Board of Trustees may be filled by the affirmative vote of a majority of the remaining Trustees though less than a quorum of the Board of Trustees. A Trustee elected to fill a vacancy shall be elected for the unexpired term of his or her predecessor in office.

Section 2.05. **Removal**. At any regular meeting, or at any special meeting called for such purpose, any Trustee or Trustees may, by vote of a majority of the entire Board of Trustees be removed from office with cause, or by vote of two-thirds ($2/3^{\text{rds}}$) of the entire Board of Trustees be removed from office without cause.

Section 2.06. **Absenteeism**. If any member of the Board of Trustees absents himself or herself from three (3) consecutive regular meetings of the Board, his or her place may, by $2/3^{\text{rds}}$ vote, be deemed vacant, and a successor may be elected as above provided.

Section 2.07. **Compensation**. Trustees shall not receive any stated salaries for their services as Trustee, but by resolution of the Board of Trustees, expenses, if any, may be allowed for attendance at any regular or special meeting of the Board. Upon full disclosure to and vote by the Board, Trustees may also be compensated for extraordinary services to the corporation beyond the normal scope of duties as a Trustee. Expenses incurred on behalf of the corporation which are unrelated to attendance at the meetings may be reimbursed to Trustees upon submission of appropriate documentation to the Chair or the President.

Section 2.08. **Indemnification**. The corporation shall and hereby agrees to indemnify and defend all persons who have served or may serve at any time as officers or Trustees of the corporation, or an affiliate of the corporation, and their heirs, executors, administrators, successors, and assigns, from and against any and all loss and expense, including amounts paid in settlement before or after suit is commenced, and reasonable attorney fees, actually and necessarily incurred as a result of any claim, demand, action, proceeding, or judgment that may be asserted against any such persons, or in which any such persons are made parties by reason of

their being or having been officers or Trustee of the corporation, or an affiliate of the corporation. However, this right of indemnification shall not exist in relation to matters to which it is adjudged in any action, suit, or proceeding that any such persons are liable for gross negligence, misconduct, or fraud in the performance of their duty. The corporation shall maintain appropriate Trustee and officer liability insurance coverage.

Section 2.09. Conflict of Interest.

(a) A Trustee shall be considered to have a conflict of interest if he or she (1) has existing or potential financial or other interests that impair or appear to impair his or her independent, unbiased judgment in the discharge of his or her responsibilities to the corporation; or (2) is aware that a member of his or her family has financial or other interests that would impair or appear to impair the Trustee's independent judgment in the discharge of his or her responsibilities to the corporation. For the purposes of this provision, a family member is defined as a spouse, parent, sibling, child, (including step-parents, step-siblings and step-children) or any relative residing in the same household as the Trustee.

(b) All Trustees shall disclose to the Board any possible conflict of interest at the earliest practical time. Further the Trustee shall absent himself or herself from discussions of, and abstain from voting on, such matters under consideration by the Board of Trustees or its committees. The minutes of such meeting shall reflect that a disclosure was made and that the Trustee with a conflict or possible conflict abstained from voting. Any Trustee who is uncertain as to whether a conflict of interest may exist in any matter may request that the Board or committee resolve the question in his or her absence by majority vote. Each Trustee shall complete and sign a disclosure form provided annually by the Secretary of the Board of Trustees.

Section 2.10. Life Trustees and Non-Voting Trustees. The Board of Trustees may, from time to time by majority vote, elect and designate as Life Trustees for his or her life, persons who have served on the Board of Trustees for a period of at least six (6) years, and whose service has been a credit to the corporation. The Board for good cause may waive the 6-year requirement. The Board may also elect by majority vote Non-Voting Trustees who are not Life Trustees, but who may be employed by or serve as an independent contractor with the corporation. Life Trustees and Non-Voting Trustees shall have all of the privileges including, but not limited to, right to receive notice, attend and participate in all Board meetings and to receive all honors and privileges of members of the Board, save and except Life Trustees shall not be entitled to vote and their presence or absence may not be counted in determining the existence of a quorum.

ARTICLE THREE MEETINGS

Section 3.01. Regular Meetings. A minimum of one (1) regular meeting of the Board of Trustees shall be held each year at such times as shall be designated by the Chair or the Board of Trustees. The Board of Trustees may provide, by resolution, the time and place for holding additional regular meetings. Regular meetings shall be held at the principal office of the corporation in the absence of any designation in the notice of meeting from the Chair, the Secretary, or the President. The first regular meeting of each calendar year shall be the annual

meeting for the purpose of organization, election of Trustees, and election of officers. The regular and special meetings of the Board may be held by conference telephone or other electronic means whereby all participants can hear the other participants at the same time.

Section 3.02. **Special Meetings.** Special meetings of the Board of Trustees may be called by or at the request of the Chair, the Vice Chair, the President, or one-third ($1/3^{\text{rd}}$) of the Board of Trustees, and shall be held at the principal office of the corporation or such other place as the Trustees may determine. Actions at special meetings shall be confined to the purposes stated in the meeting Notice.

Section 3.03. **Notice.** Notice of regular meetings shall be given in a reasonable manner at least five (5) days prior to the date of the meeting. Notice of special meetings shall be given in writing by mail at least ten (10) days prior to the date of the meeting or in the case of emergency forty-eight (48) hours' notice delivered personally or by telephone or other electronic means. Neither the business to be transacted at nor the purpose of any regular meeting need be specified in the notice. Written notice of the time and place of special meetings shall be signed by the respective officers or Trustees calling such meeting and shall specify the general nature of the business to be conducted at the meeting. A written waiver or attendance of a Trustee at a meeting shall constitute a waiver of notice of that meeting except when the Trustee attends for the express purpose of objecting to the transaction of any business in that the meeting is not lawfully called or convened.

Section 3.04. **Quorum and Voting.** One-third of the Board of Trustees, but in no event fewer than three, shall constitute a quorum for the transaction of business at any meeting of the Board of Trustees and, except as otherwise provided by law or these Bylaws, the act of a majority of the Trustees present at any meeting of the Board of Trustees at which a quorum is present shall be the act of the Board of Trustees. Trustees shall be deemed present at a meeting when present in person or by means of a conference telephone or similar communications equipment by means of which all persons participating in the meeting can hear each other at the same time. In the absence of a quorum, a majority of the Trustees present, or if only two Trustees are present, either Trustee, or the sole Trustee present, may, with the above notices, adjourn the meeting to a day certain or from time to time until a quorum is present. At any rescheduled meeting at which a quorum is present, any business may be transacted that might have been transacted if the meeting had been held when originally called. The Board of Trustees may establish rules for voting by proxy.

Section 3.05. **Presumption of Assent.** A Trustee of the corporation who is present at a meeting of the Board of Trustees at which action on any corporate matter is taken shall be presumed to have assented to the action taken unless his or her dissent shall be entered in the minutes of the meeting or unless he or she shall file his or her written dissent to such action with the person acting as the secretary of the meeting before the adjournment thereof or shall forward such dissent by registered mail to the Secretary of the corporation immediately after the adjournment of the meeting. Such right to dissent shall not apply to a Trustee who voted in favor of such action.

Section 3.06 **Action by Written Consent.** Except for the actions set forth in Section 4.01(a) below, after notice as required for a meeting, any action that could be taken at meeting can be taken or authorized by the written consent of three-fourths ($3/4^{\text{ths}}$) of all of the Trustees

in office and entitled to vote on the matter. The consent may be evidenced by a written document, by facsimile, by email, or by other electronic means that can be preserved. For purposes of determining three-fourths, the number of Trustees shall exclude those who have recused themselves or have a conflict of interest related to the proposed action.

ARTICLE FOUR COMMITTEES

Section 4.01. General.

(a) The Board of Trustees, by resolution adopted by a majority of the Trustees in office, may designate one or more committees which, to the extent provided in such resolution, shall have and exercise the authority of the Board of Trustees; but the designation of such committees and the delegation thereto of authority shall not operate to relieve the Board of Trustees, or any individual Trustee, of any responsibility imposed on him or her by law. Notwithstanding the above, the Board of Trustees may not delegate the following powers: (i) to appoint or remove Trustees or elective officers, including the President; (ii) to fill vacancies on any committee which has the authority of the Board of Trustees; (iii) to adopt, amend, or repeal Bylaws or Articles of Incorporation; (iv) to set the compensation of Trustees or of officers elected or appointed by the Board of Trustees; (v) to amend or repeal any resolution of the Board of Trustees which by its express terms is not so amendable or repealable; (vi) to appoint other committees which have the authority of the Board of Trustees; (vii) to change the mission and purposes of the Corporation; (viii) to authorize the sale, lease, exchange, or mortgage of all or substantially all of the corporation's property and assets; or (ix) to authorize voluntary dissolution of the corporation.

(b) Each committee shall have a written statement of purpose and primary responsibilities as approved by the Board and from time to time report to and advise the Board on corporate affairs within its particular area of responsibility and interest.

(c) Committee members (excluding the Executive Committee) shall be appointed by the Chair after consultation with members of the Board and the President (if a different person from the Chair), and shall serve at the pleasure of the Board. Membership of committees shall consist of two or more Trustees in office and, except for the Executive Committee and Purpose Committee (if there be one), may include members who are not members of the Board of Trustees, provided that the committee chairs, vice chairs, and a majority of each committee's members shall be Trustees. Any member of a committee may be removed by the Chair (except the Executive Committee) or by the Board, whenever, in the Chair's or the Board's judgment, the interests of the corporation shall be served by such removal. The Chair shall have the power at any time to fill vacancies in and to change the members and leadership of any committee, except the Executive Committee. The Board of Trustees shall have the power at any time to change the size of and discharge any committee, and in the absence of action by, or disagreement with the Chair, shall have the power at any time to fill vacancies in or change the members and leadership of any committee.

(d). **Committee Quorum and Vote.** Except for the Executive Committee, one-third ($1/3^{\text{rd}}$) of the membership of a committee (but no less than two) shall constitute a quorum, and the committee may act by a majority of the members present at a meeting at which a quorum is present. Meetings may be by conference telephone or similar electronic equipment in which all members can hear all other members who are participating.

Section 4.02. Executive Committee.

(a) The Executive Committee shall be composed of the Chair, Vice Chair, Secretary, and Treasurer, and if so specified by action of the Board, the Executive Committee shall also include other members of the Board of Trustees who are elected by the Board to serve for terms of one year. The Executive Committee shall have such powers and shall perform such duties as the full Board of Trustees, except that the committee shall have no power prohibited in 4.01(a) above.

(b) The Executive Committee shall be organized and shall perform its functions as directed by the Board and shall report periodically to the Board in a manner such that the Board is fully and timely informed about the actions of the Executive Committee. The Executive Committee shall be chaired by the Chair of the Board of Trustees. A majority of the membership shall constitute a quorum, and the committee shall act by a majority of the members present at which a quorum is present. Any action duly taken by the Executive Committee within the course and scope of its authority shall be binding on the corporation, but all such actions shall be presented at the next succeeding meeting of the Board for ratification.

Section 4.03. Purpose Committee

(a) If created by the Board, the Purpose Committee shall have at least three members, all of whom shall be voting Trustees. The committee's chair, vice chair, and members shall be appointed for renewable one-year terms.

(b) The primary purposes of the Purpose Committee are threefold: (1) it shall ensure that the Board's membership and leadership consists of highly qualified and committed individuals; (2) it shall ensure that the mission of the corporation is reviewed by the Board from time to time and that the operations of the corporation are consistent with the mission; and (3) it shall periodically recommend initiatives by which the Board shall assess its performance.

ARTICLE FIVE OFFICERS

Section 5.01. Enumeration of Offices. The corporation shall have as officers a Chair, Vice Chair, Secretary, Treasurer, and if desired by the Board, a President and Assistant Secretaries, all of whom shall be members of the Board of Trustees, except that a President employed by the corporation and any Assistant Secretaries need not be members of the Board of Trustees unless elected to the Board as determine in the discretion of the Board of Trustees. The President in his discretion may appoint one or more administrative officers as the business of the corporation may require. If there is no President employed by the corporation, the Chair shall

have the title of President. An individual Trustee may hold two offices except that the offices of President and Secretary may not be held by the same individual.

Section 5.02. **Election and Term of Office.** The principal officers of the corporation shall be elected by the Board of Trustees at its first regular meeting of the year, generally for terms of one year, or longer terms as determined by the Board of Trustees. Each officer shall hold office until his or her successor is elected and qualified, or until his or her resignation, death, or removal.

Section 5.03. **Removal.** Any officer may be removed from office at any time, with or without cause, on the affirmative vote of a majority of the Board of Trustees. Removal shall be without prejudice to any contract rights of the officer removed.

Section 5.04. **Vacancies.** Vacancies in offices, however caused, may be filled by election by the Board of Trustees at any time for the unexpired terms of such offices.

Section 5.05. **Chair.** The Chair shall preside at meetings of the Board and the Executive Committee, have the right to vote on all questions, perform the usual duties of a Chair, serve as the primary spokesperson for the Board, and perform such other duties as may be required of him by the Board. The Chair shall be an ex officio member of all committees of the Board of Trustees. The Chair shall propose nominees for appointment to all committees and may appoint members of all committees that are not authorized to take action.

Section 5.06. **Vice Chair.** In the absence of the Chair of the corporation or in the event of his or her death or inability or refusal to act, the vice Chair shall perform the duties of the Chair and, when so acting, shall act with all of the powers of and be subject to all the restrictions on the Chair. In the absence of both the Chair and Vice Chair, the Board of Trustees may appoint a Chair Pro Tem, or if it fails to do so, the President of the corporation may serve as Chair, Pro Tem.

Section 5.07. **Secretary.** The Secretary shall be responsible to ensure that accurate and timely minutes of all meetings of the Board are made and distributed to all Trustees; shall be responsible for the custody and safekeeping of the minute book; shall attest the signature of the Chair and President on all documents requiring such attestation; shall be responsible for the custody, safeguarding, and use of the seal of the corporation and shall impress it upon all documents requiring such seal; shall be responsible to ensure that meetings are properly scheduled and trustees are properly notified; shall keep, or cause to be kept, at the principal office of the corporation a complete register showing the names, addresses, and terms of the Trustees then in office; and shall perform all duties as are ordinarily performed by corporate secretaries. The Secretary shall be the secretary of both the Board of Trustees and of the corporation.

Section 5.08. **Treasurer.** The Treasurer shall serve as the Board's principal leader on financial management policy matters and may serve as the chair of the finance committee of the Board. The Treasurer shall be responsible to ensure that all Trustees regularly receive timely and comprehensive financial statements and other financial reports from the administration and shall perform all of the duties incident to the office of Treasurer and such other duties as from time to time may be assigned to him.

Section 5.09. **President**. Subject to any guidance given by the Board of Trustees, the President shall be the chief executive officer of the corporation. The President shall supervise and direct all the business and affairs of the corporation according to his own discretion whenever and wherever it is not expressly limited by the Board of Trustees and shall perform such other duties as may be prescribed by the Board. The President may sign, with the Secretary, Assistant Secretary, or any other officer of the corporation so authorized by the Board of Trustees, any deeds, mortgages, bonds, contracts, or other instruments that the Board of Trustees has authorized for execution, except when the signing and execution thereof has been expressly delegated by the Board of Trustees or these Bylaws to some other officer or agent of the corporation or is required by law to be otherwise signed or executed. Board authorization for execution of contractual instruments shall be presumed except in circumstances in which the Board has, in its governance authority, expressly reserved an approval requirement unto itself. The President shall also make annual reports to the Board of Trustees and from time to time shall report to the Board all matters that should be brought to their attention. If the President is not also the Chair, then the President shall be an ex-officio member of the Board of Trustees without the power to vote, and his or her presence at meetings shall not be counted as part of quorum determinations.

Section 5.10. **Assistant Secretary(ies)**. The Board of Trustees may appoint one or more persons to serve as an Assistant Secretary of the Board of Trustees and/or of the corporation. In the absence or disability of the Secretary, he or she shall attest documents and attach the seal of the corporation and perform all duties incidental to the office of the Secretary and such other duties as may be assigned by the Chair or the President.

Section 5.11. **Administrative Officers**. Administrative officers appointed by the President, shall exercise such powers and perform such duties as may be delegated to them by the President. The numbers, titles, and responsibilities of the Vice Presidents shall be determined by the President, but such determinations shall be subject to review and modification by the Board of Trustees at its discretion.

Section 5.12. **Absence or Disability of Officers**. In the case of the absence or disability of any officer of the corporation and of any person hereby authorized to act in his or her place during his or her absence or disability, the Board of Trustees may by resolution delegate the powers and duties of such officer to any other officer or to any other person whom it may select.

ARTICLE SIX CORPORATE ACTIONS

Section 6.01. **Contracts**. The Board of Trustees may authorize any officer or officers, or any agent or agents of the corporation, to enter into any contract or to execute and deliver any instrument in the name of on behalf of the corporation, and such authority may be general or confined to specific instances. The President shall be presumed to have such authority except in circumstances in which the Board has, in its governance authority, expressly reserved an approval requirement unto itself.

Section 6.02. **Checks, Drafts, or Orders.** All checks, drafts, or other orders for the payment of money by or to the corporation and all notes and other evidence of indebtedness issued in the name of the corporation shall be signed by such officer or officers or agent or agents of the corporation, and in such manner, as shall be determined by the President, or his delegate, subject to the governance, if any, of the Board of Trustees.

Section 6.03. **Deposits.** All funds of the corporation not otherwise employed shall be deposited to the credit of the corporation in such banks, trust companies, or other depositories as the President, or his delegate, may select, subject to the governance, if any, of the Board of Trustees.

Section 6.04. **Acquisition and Encumbering of Property.** The Board of Trustees shall have the power to acquire by purchase, gift, or any other lawful manner, any property, both real and personal, rights, or privileges that the corporation may lawfully acquire, at such price and on such terms and conditions as the Board shall deem proper. The Board shall also have the power to create, make, and deliver mortgages, bonds, deeds of trust, trust agreements, security interests, and any other kind of lawful encumbrance on property of the corporation, both real and personal, for the acquisition of such property or for any other lawful corporate purpose. The Board of Trustees shall have the power to appoint any person or corporation to act as trustee for the corporation with respect to any such property and to authorize such trustee to execute such instruments and do all such acts and things as may be required in relation to the trust and the trust property. The Board of Trustees may authorize the officers of the corporation or other agents to take the actions and exercise the powers provided in this Section 6.04.

ARTICLE SEVEN MISCELLANEOUS

Section 7.01. **Fiscal Year.** The fiscal year of the corporation shall begin on the 1st day of January of each year and end at midnight on the 31st day of December of the same year.

Section 7.02. **Construction and Definition.** Unless the context requires otherwise, the general provisions, rules of construction, and definitions contained in the General Corporation Law of the State of Texas shall govern the construction of these Bylaws. Without limiting the foregoing, the masculine gender includes the feminine and neuter, the singular number includes the plural, and the plural number includes the singular; "shall" is mandatory and "may" is permissive; and "person" includes a corporation as well as a natural person.

Section 7.03. **Code of Conduct.** The Board of Trustees hereby establish the following Code of Conduct which shall serve as a moral compass and ethical guide for the operation of the Board of Trustees and of the corporation:

- a. Loving one's neighbor as one's self.
- b. Being honest and truthful.
- c. Being gracious to one another.
- d. Fostering and acting in wisdom.
- e. Being sensitive to the culture of others.
- f. Serving the highest purposes.

- g. Observing and maintaining the sanctity of life.
- h. Stewarding the earth and its resources.
- i. Being charitable and compassionate.
- j. Being subservient to the Will of God the Father.
- k. Facilitating and promoting the strength and unity of the family of humanity.
- l. Being mindful of the power and influence of our words and actions.
- m. Reflecting the example and Spirit of Christ in all we do and say.

ARTICLE EIGHT ARTICLES AND BYLAWS

Section 8.01. **Maintenance of Certificate of Incorporation and Bylaws.** The original or a copy of the Certificate of Incorporation and Bylaws of the corporation, as amended or otherwise altered to date, and certified by the Secretary of the corporation, shall at all times be kept at the principal office of the corporation, and copies made available to any Trustee who may request a copy.

Section 8.02. **Amendments.** These Bylaws may be altered, amended, or repealed and new Bylaws may be adopted by either: (a) two-thirds ($2/3^{\text{rds}}$) of the number of Trustees then in office at any regular meeting; (b) two-thirds ($2/3^{\text{rds}}$) of the number of Trustees then in office at any special meeting, if at least 15 days' written notice is given of intention to alter, amend, or repeal or to adopt new Bylaws at such meeting; or (c) unanimous written consent of all Trustees then in office without a meeting.
