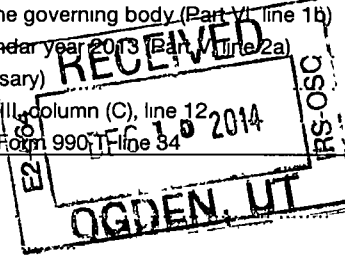

Therefore for its 2013 audited financial statements and Form 990, it has written off such amounts as a bad debt expense.

Upon discovery of such misappropriation, the organization has taken various steps to strengthen its internal control procedures with the goal of minimizing the likelihood that a similar event will occur in the future. Such changes included but not limited to a greater

segregation of duties, timely review of financial transactions by management, hiring of stronger and more experienced accounting personnel.
