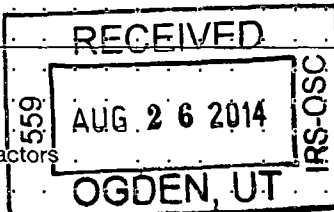

develop. Midwives are trained through the accompaniment of mentors who are nurses from health centers serving the communities

Teaching courses, regular meetings and on-going relationships provide support to midwives as they continue, as they have throughout history, to attend low-risk births. During the 6-month period from July through December 2013, nineteen (19) traditional midwives and community health workers participated in 2 to 4 day internships at health posts or hospitals, thirty one (31) attended a 2 day workshop, 31 community visits were made by mentors to enhance recently-learned skills, and 34 skills monitoring visits were made by mentors and project staff. In addition, seven (7) meetings were held (with 92 participants representing 38 governmental agencies, NGOs, schools and other community organizations) to coordinate trainings and services provided.
