### Description of Achievements for 2013

ROP serves a very diverse community, including African Americans, Caucasians and Hispanics, and over the past several of years, we have also seen a significant increase in the number of refugees and immigrants moving into our neighborhood. Like many others in our community, most refugees are introduced to ROP through our food and clothing banks where the refugee community makes up more than one-third (food bank) and more than two-thirds (clothing bank) of the people served. The refugee community also has unique sets of needs, beginning with language and cultural barriers. ROP provides them with English as a Second Language (ESL) classes and we are inspired by their hard work as they progress, albeit often at a slow rate. Many of these people did not have a chance at an education in their own countries and endured unimaginable persecution before arriving in Aurora. The majority of our students are from Burma, with Nepal being a close second. We also have students from Iraq, Ethiopia, and Latin American countries.

The assistance these refugees need is too great for any one agency to provide, so in 2013, ROP created a new staff position, Director of Refugee Resources and Outreach, and began a targeted effort to reach out to our refugee neighbors and to collaborate with others who are working with the same population in Aurora. In 2013, we partnered closely with Denver Rescue Mission (DRM) in two separate outreach events to the refugees in our community, and looking forward we expect to continue partnering with DRM and several other organizations in meeting the needs of our growing refugee population.

In 2013, ROP also took intentional steps beyond our regular programming and toward our vision of becoming a catalyst for connecting people and organizations. Last summer, we initiated a monthly prayer breakfast for the pastors ministering in our community where we pray for and look for ways to support one another. We have invited these churches to partner with us in this year's Back to School Outreach. For the first time, back packs will be allocated to the churches to bless their congregation and to help them reach out to others in their community, rather than all back packs coming straight from ROP.

Last year, we also saw progress in connecting suburban churches with urban churches by organizing and creating opportunities for groups of volunteers and individuals to use their talents and resources to serve. For example, through several sessions last April and May members of Cherry Hill Community Church taught 30 leaders of Burmese churches how to have more effective Sunday school programs for their kids. In August, Foothills Bible Church and Eastern Hills Community Church played huge roles in pulling off 2013's Back to School Outreach which fed more than 2,000 people and put back packs filled with school supplies in the hands of more than 1,000 kids. Other examples include large teams of 100+ volunteers serving more than 300 families at ROP's Thanksgiving Outreach (Denver United Church and others) and serving more than 150 homeless and near-homeless people a hot breakfast and warm clothing on Christmas morning (Restoration Community Church).

### 2013 Program Results

In 2013, more than 4,400 unduplicated individuals were served through ROP Resource Ministries, including the following programs:

- Food Bank: 965 different households received food during the year, representing at least 3,665 different adults and children. On a weekly basis the food bank served an average of 95 households.

- GED Classes: 101 different students attended at some point during the year. Some came regularly. Others only attended sporadically. The monthly average was 26 different students. 32 individual tests were taken, and two students met all requirements to earn their GED. Progress is slow due to language barriers and inconsistent class attendance. Indeed, some of our students will probably never pass their GED, but we welcome them and seek to meet their more basic needs for relationship and encouragement. In January 2014, the Colorado GED test changed to an online and more challenging format. As a result, some of our tutors teach basic computer skills while other tutors concentrate on the academic material required to earn the GED. Thanks to a 2013 grant, ROP's GED classroom is now fully equipped with seven new computers.
- ESL Classes: 107 students attended ROP's English as a Second Language (ESL) classes in 2013. Sixteen of the students have obtained work, and 14 have advanced to higher levels. These may not seem like a huge numbers, but student literacy levels are often in the preliterate range, and there is no commonality between their languages and English. Some will take a very long time to achieve advancement. Many of the students are mothers and seniors, who do not plan to work jobs outside of the home. Like some of the GED students, many ESL students also come in order to find connections and encouragement that they do not find elsewhere in their lives.
- Outreach: 2013 saw some rethinking in ROP's Outreach activities. Large outreach events can be quite expensive. They do very little in terms of building relationships with people. And they tend to be one-way giving events, i.e. events where people just receive stuff for free with no investment on the part of the participant (see "Lessons Learned" below). On the other hand, large outreach events provide one of our best opportunities to give volunteers from our supporting churches an opportunity to "dip their toe in the water" of city ministry and be introduced to ROP. They also give us a chance to share the Gospel with people and build awareness and remind participants of the services ROP offers. With these considerations in mind, ROP has scaled back its large outreaches to just two events per year, the Back to School Outreach in early August and our Thanksgiving Outreach. 2013's outreaches saw 433 volunteers serve almost 3400 people. And we saw more than 200 people either receive for the first time or recommit their lives to Jesus Christ.
- Street Ministry: Our team served almost 2900 hot meals to the homeless and near homeless over the course of 2013. Regardless of the weather, people knew they could not only count on some hot food (and when available, warm clothing and personal hygiene items), but they would also encounter a listening ear and a caring heart from our Street ministry team.

Our primary objectives for ROP Youth Ministries include keeping the kids in school and teaching them to make good decisions, so that they become self-supporting and contributing members of their families and communities. During 2013, we served 227 different youth ages five to 18. We try to reach and influence them before they drop out of school and become problems. None of the kids that participated regularly in our programs in 2013 dropped out of school or got in trouble with the legal system. Overall, we have seen improvement in behavior in all of our youth. Additionally, we have seen improvement in the students who participate in our after-school tutoring program, both in academic skills and behavior. We are currently developing a system to better measure how much academic improvement we are seeing in our youth.

While ROP's overall spending for 2013 came in about 3% lower than budgeted, ROP Youth Ministries expenses were greater than budgeted, especially for camps and off-site activities. However, this was mostly good news as it reflects the participation of more kids. In fact, we doubled the number of youth served in the 2013 summer program, and the year-round programs grew by about 50%. As a result, we are increasing our budget for youth program expenses in 2014.
