The mission of Imagine Science Films Corp is to promote a high-level dialogue between scientists and filmmakers This is achieved by encouraging a greater collaboration between scientists who dedicate their lives to studying the world we live in and filmmakers who have the power to interpret and expose this knowledge, ultimately making science accessible and stimulating to a broader audience Our goal is to draw attention to the sciences, whether it is through art or community outreach efforts

In 2013, Imagine Science Films Corp held its 6th Annual New York Imagine Science Film Festival from October 11-18,2013 with one of the largest film programs to-date The festival featured over 65 films from 14 different countries With new events, panels and receptions, the 2013 festival offered an exciting eight days filled with science and cinema The festival opened at Google, NY celebrating the festival theme of "Data Visualization", with evenings devoted to science shorts, documentaries, real footage from lab experiments, discussions about the current state of visualizing science through film, and a closing reception in partnership with the Tribeca Film Institute ISFF screenings took place at venues throughout the five boroughs of New York, opening at Google NY on October 11th and closing at Eugene Lang at The New School on October 18 Other venues included Made in NY Media Center, Museum of Moving Image, Anthology Film Archives, NeueHouse, Rockefeller University, New York Academy of Science and the Liberty Science Center The 6th annual ISFF was our bigegest year yet due to our partnership with Google Opening night was sold out, with over 300 guests in attendance, including Neil deGrasse Tyson Each night was a full house with a diverse audience of PHD and MD students undergraduates, high schools and academics, and science and film enthusiasts Our main sponsors included our new presenting sponsor, Google, as well as our founding Sponsors Science/AAAS and Nature Publishing Group In addition, four awards totaling \$6,000 were given out to five recipients for the Nature People's Choce, Nature Scientific Merit Award, AAAS Scientist Awards and the Imaginal Disc Visual Science Award Our non-monetary reward was sponsored by CineGlobe at CERN where they hosted the winner in Geneva for a screening of the winner film at the CineGlobe science film festival After holding its first ever Satellite festival in June 2012 in Dublin, ISF hosted festivals in Bologna, Italy and Kaluga, Russia in 2013 We also partnered with Google In addition, Imagine Science Films continued its international reach with its fourth Artists in Residence program including ten internationally renowned artists
