IN DISCUSSIONS WITH THE IRS, NO 990N IS REQUIRED TO BE FILED IN THE YEAR OF REINSTATEMENT RETROACTIVELY TO 2012. THEREFORE, THE FIRST YEAR REQUIRED FOR A RETURN IS 2013 AND TRR HAD REVENUE IN EXCESS OF 50,000 IN 2013 AND IS, THEREFORE, FILING A 990EZ.
