Corazón Puro, led by the Franciscan Friars of the Renewal, follows a peer-to-peer ministry model. Corazon Puro offers leadership formation to the youth and young adults in the inner city and raises them up to be missionaries. They in turn take the message and train youth and young adults in other countries and form them into leaders. Corazon Puro holds 3-4 leadership formation days of reflection, 2 leadership retreats and several-session workshop series (missionary training etc) annually.

Inner City Youth and Young Adults

Corazón Puro is an Apostolate that reaches out to underprivileged (particularly Hispanic) youth and young adults formation on the truth and meaning of Human Dignity through a Theology of the Body. Corazon Puro offers in Spanish and English: Hope through the message of Christ's Mercy; Support for those who strive to be pure in heart. Practical steps to live our God-given dignity. Corazón Puro holds monthly meetings for 150+ people and retreats 2-3 times annually for 65-80 people. Corazón Puro also offers opportunities to serve with the Franciscan Friars of the Renewal, including outreach to the poor and homeless, to those in prison, victims of human trafficking, the elderly and those suffering from post-abortion.

International Aid

Corazón Puro has brought the message of chastity and freedom to the young people in Honduras, Nicaragua and the Dominican Republic in 2013. We have also brought supplies and gave leadership development workshops to the youth and young adults in these countries.
