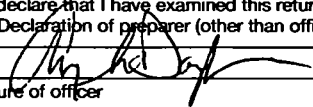

PART I Line 16 - \$42,885 for ministry expenses in South Africa, Kenya & Uganda (includes food and living expenses for team trips, costs to run ministry house in South Africa, cost to run Vacation Bible School programs, AWANA programs and youth camps in South Africa, food parcels for poor families, Christmas program for street boys in Kenya, school supplies for orphans in Uganda, construction of porch, garden and chicken coop and purchase of furnishings for ministry house in South Africa, etc)

PART I Line 20/Part II Line 24 - Purchase of following: \$170 - 1TB travel drive; \$200 - 2TB external hard drive; \$300 - Lenovo laptop; \$100 tents

PART III Line 28 - Youth development - Provided life skills, mentorship, and leadership training to 72 orphaned teenagers in one of poorest regions of South Africa.
