Montana Conservation Voters, Inc.'s primary exempt purpose is to educate and activate voters to be vital and effective participants in Montana's democratic process, to protect air and water quality, public health, fish and wildlife and open space. MCV informs the public about the votes and actions of local, state and federal elected officials pertaining to conservation and environmental issues, and encourages their involvement in government.

Form 990, Part III, Line 4a - Program Service Accomplishments

Conservation Policy Campaign: MCV's 2013 Conservation Policy Campaign was dedicated to the defending Montana's clean air, clean water, fish and wildlife protections and responsible growth policies in the legislature. With support from MCV Education Fund, MCV convened weekly "Conservation Working Group" meetings (comprised of 13 allied groups also working in the legislature) to discuss priorities and coordinate public education. MCV prepared weekly "Hot Lists" for legislators and other public officials, organized one meeting with the Governor and ongoing meetings with administrative staff to promote passage of legislation to protect the environment, and defeat bills attacking the environment and Montana's growing renewable energy industry. MCV also coordinated, with the Conservation Working Group, one legislative social attended by 176 people, and 4 lobby days (see b, below). Accomplishments include the defeat or a veto of all but 1 of over 80 bills that would have harmed Montana's clean water, wild country and renewable energy, and adoption of a positive interim study proposal on the state's Renewable Energy Standards.

After the legislature, MCV staff participated in interim legislative committee meetings of the Environmental Quality Council and Energy Committee and were asked to help with public education and outreach regarding the Salish Kootenai Water Compact,

to enable its adoption leading up to the 2015 legislature. MCV also continued its outreach work with the Bullock Administration to foster support for energy conservation and renewable energy, and to ensure input on appointments to state boards and commissions.

At the federal level, MCV advocated passage of the Production Tax Credit (to promote renewal energy), as well as range of public lands policies including full funding for the Land and Water Fund. MCV also worked to reform chemical policy and continued its work to defend the Clean Air Act. Staff took three trips to Washington DC to lobby Congress, and convened meetings with Sen. Tester in Montana to discuss the Clean Air Act, involving college students at MSU (Bozeman). This outreach to young voters helped engage them more deeply in the climate change debate.

In the summer and fall of 2013, MCV chapter leaders and staff prepared non-partisan questionnaires mailed it to candidates running for city office in 7 communities, and 2 chapters invited participation at chapter membership meetings. MCV also communicated with members and associate members about what was at stake in the 2013 city elections and provided a voter guide as public information.

Outreach and Community Organizing: 2013 was a banner year in MCV's outreach and organizing program. Chief accomplishments included a door to door membership canvass in 7 communities which resulted in 18,212 door knocks, conversations with nearly 8,000 voters about the importance of protecting public lands in Montana, and the enrollment of 793 new MCV members and nearly 3,000 new associate members.

MCV's second accomplishment was passage, as part of a coalition of groups, of the "Mountain Line" mill levy, to improve and expand Missoula, MT's bus service. The policy reduces auto-emission pollution and single vehicle use of Missoula residents by expanding the bus service and improving service. It was the only environmental measure on the ballot in any Montana community in November, 2013. MCV coordinated a door to door canvass and phone bank program to enroll voters and to ensure return of their mailed ballots.

MCV's four chapters, Yellowstone Cty, Gallatin-Park Cty, Missoula Cty and Flathead Cty each convened membership meetings after the 2013 legislature, inviting the public and legislators. Chapter boards met 8-9 times per year.

Leadership and Staff Development: A hallmark of MCV's 2013 work was a series of 4 leadership trainings held monthly as part of "Lobby Days" in Helena, MT during the legislative session. A total of 121 people attended (some more than once) and expanded their skills and knowledge of state legislative issues and policy advocacy.

MCV used some of the components of these trainings to develop skills of Missoula-area members to work effectively for the passage of the Mountain Line mill levy proposal (see c, below). These trainings were also well evaluated, and MCV used feedback to improve each one of its trainings.

Two MCV staff and 2 board members attended the national League of Conservation Voters training meeting in Grand Rapids, MI; two staff and 1 board member attended a fundraising training in Seattle, WA; three leaders and 2 staff attended 2 public

policy and advocacy training sessions in Washington, DC. Additionally, MCV staff began training for a conversion to a new data base, as part of a 4-state pilot project with the national League of Conservation Voters. MCV held one chapter board orientation session in 2013 attended by 6 board members, and an orientation session for 2 new board members. MCV's Executive Director and a board member also attended a financial management workshop in November, 2013 which is resulting in improvements.

Ongoing staff development included participation in monthly League of Conservation Voters Development Director calls, monthly organizing calls and participation at LCV's Executive Director meeting which included a staff development component. MCV staff carried out their professional development plans including training on civic engagement, environmental policy and fundraising skills. MCV's Executive Director concluded participation in the Leadership Montana program.
