Leadership and Staff Development: MCVEF's signature "Conservation Leadership Project" used its "Ladder of Engagement" to reach out to 121 citizens to encourage them to attend leadership trainings on state legislation and public policy. The trainings were held monthly from January - April, 2013. Three of these individuals became members of MCVEF leadership. Staff made calls and sent emails to those on levels 4 and 5 of the Pyramid in Missoula to be part of a campaign to improve the Missoula public transportation system, resulting in 21 people attending a training on how to reach out to citizens at the doors or over the phone. One Board orientation session was conducted. Two Board members attended the LCV/LCVEF annual meeting and one attended a summer, 2013 fundraising training. Total expense: \$41,880

Montana Conservation Voters Education Fund's primary exempt purpose is to provide research and public education to the members of conservation and environmental organizations in Montana, and other interested Montanans to protect Montana's clean air and water, wildlife, forests and open space. MCVEF seeks a more informed, educated and empowered conservation and environmental community in Montana, who takes part in this state's democratic process.

Form 990, Part III, Line 4a - Program Service Accomplishments

Conservation Policy Program: This year, MCVEF had a robust public policy and public education program related to the 2013 Montana State Legislature. A grant of \$40,000 was provided to Montana Conservation Voters for public policy services, including analysis of state legislative proposals; preparation of weekly "Hot Lists" for conservation and environmental groups, legislators and other public officials on key legislative proposals; development and distribution of briefing papers; coordination of weekly constituency outreach calling; and convening of one state legislative social with allied groups.

The range of issues covered include renewable energy and energy conservation policies; clean water laws; water rights laws; bills affecting bison and overall management of fish, wildlife and public lands; sustainable agriculture policies; and clean air laws.

MCVEF also conducted meetings with officials of the administration of Governor Steve Bullock in its policy analysis work, and provided information on the impact of bills on Montana water, air, fish and wildlife, clean energy economy and public health.

MCVEF also began work with allied groups to monitor the interim legislative

activities of the Energy and Telecommunications Committee and the Environmental Quality Council.

A new development in fall, 2013 was the convening of a retreat convened by MCVEF which brought together 22 participants from 14 organizations to identify environmental policy priorities for 2 - 4 years forward, and establish working groups to move the policies forward. MCVEF's new Program Director works on implementation.

At the federal level, MCVEF coordinated the Climate Action Coalition and Clean Air Campaign, working in partnership with the national League of Conservation Voters Education Fund and over a dozen conservation, public health and fish and wildlife groups. The key focus was to educate citizens, local and statewide decision makers on the impacts of climate change and clean air policies on public health, fish and wildlife and a clean energy future, and to ensure the authority of the Environmental Protection Agency to protect public health under the Clean Air Act, including from the negative impact of carbon emissions. MCVEF leaders were part of letters to the editor and guest commentaries, and attended over a dozen meetings and events on the Clean Air Act, climate change and the Production Tax Credit. Additionally, MCVEF sponsored or co-sponsored eleven meetings and events throughout 2013, and reached out to legislative, statewide and local officials to engage them in this dialogue as well.

MCVEF Conservation Voters Education Fund expanded its work on safe chemicals in 2013 by holding an April 22nd Stroller Brigade in Bozeman to elevate the importance of action to reduce toxic chemicals in household products. MCVEF leaders worked to educate the public and local decision makers about the re-authorization of the

federal Toxics Substances and Control Act (TSCA) and proposals to ensure greater safety in household products and chemicals. A fall, 2013 "Day of Action" included a series of letters to the editor, a guest commentary, and a statewide radio broadcast, tied to a trip by two MCVEF leaders to join forces with other state leaders for a federal "Day of Action." MCVEF partners with the national League of Conservation Voters Education Fund and the Safe Chemicals Coalition on this campaign.

MCVEF reduced its work locally with the Missoula City Commission, the Bozeman City Commission, the Billings City Council and the Whitefish City Council on city policy related to trails, infill development, smart growth and reducing the cities' carbon foot print.

Total expense: \$133,505

Community Organizing, Outreach and List Enhancement: In 2013, MCVEF launched a first-ever door to door outreach campaign in 7 communities to speak with citizens about policies affecting the Rocky Mountain Front and the other iconic Montana Treasures. Petition signatures were gathered from 3,906 citizens in support of protection of public lands, and presented to Sen. Max Baucus in August. MCVEF continues communication with these individuals via email and social media and works with key allies to ensure consistent information and messaging.

A second major accomplishment was MCVEF's "Mountain Line" campaign in the fall of 2013, engaging and educating citizens in a public policy debate to improve bus service in the city of Missoula. MCVEF's Field Director coordinated leadership meetings and worked with allies to visit with citizens at their doors, over the phone, and to write letters to the editor on the proposal.

MCVEF coordinated the Billings Conservation Roundtable and the Missoula Conservation Roundtable, which convened network gatherings held 9 times throughout the year as a public service to conservation and environmental groups in those communities.

Attendance at the Roundtables ranged from a low of 6 to a higher of 31, with an average attendance of 18 in Billings and 16 in Missoula. MCVEF's outreach program also included periodic participation in the Great Falls Conservation Roundtable and the Flathead Conservation Roundtable during the year. MCVEF's outreach program in 2013 included participation in the Montana Voices non-partisan collaborative, bringing together groups that work on civic engagement and progressive public policy. MCVEF staff also did one on one visits with partners in the Conservation Working Group, a statewide coalition working on environmental policy.

MCVEF used its List Project during the 2013 legislature and its summer canvass to reach out to the members of participating conservation and environmental groups about key legislative proposals. The Project was also used to mail a mid-term and final legislative report. In the fall, the project aided mailings to a coalition of group members to attend gatherings about clean air and climate change (featured in MCVEF's conservation Policy Program). MCVEF is transitioning to a new data base and this work, which will impact the List Project, is to conclude in mid-2014.
