



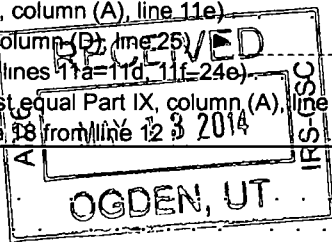

Group Emotional Support Each year, Special Ops Survivors holds at least one survivors' conference Each conference is unique in its own way, but the goal of each conference is to promulgate peer-based emotional assistance and provide practical life-skills training for survivors to better manage their day-to-day lives Special Ops Survivors covers the cost of transportation, lodging, all workshop costs and most meals for our survivors The 2013 spring survivors' conference was held in Tampa, FL from April 4 - 7 The focus of this weekend was helping the survivors learn how to define and tell their stories, rather than letting their stories define them 25 survivors from 11 states attended the conference The 2013 fall survivors' conference was held in Colorado Springs, CO from October 17 - 21 The focus of this weekend was on how nutrition and physical wellness play into the survivors' grief and healing 12

Individual Emotional Support The key to our approach to healing is based upon finding common ground in relationships Our approach provides the opportunity for survivors to come together with their peers to find comfort and healing in a judgement-free environment Unlike a traditional mentorship model, our approach is grounded in a team perspective in which we believe that every survivor brings a unique and valuable perspective to the group We believe this approach offers the new survivor a safe and understanding sounding board while, at the same time, helping the more experienced survivor progress in her or his own healing processes Special Ops Survivors recognizes that after the memorials are over, even the most well-intentioned family, friends, and neighbors go back to their everyday lives -- sometimes leaving survivors feeling forgotten and alone Our mission is to let surviving spouses know they are not alone We do this by sending personal outreaches to our survivors throughout the year to let them know that they remain in our thoughts and hearts
