Statement of Program Service Accomplishments

Mmametlhake Family Care Centre (MFCC)

MFCC provides help for those suffering from the consequences of HIV/AIDS with an increasing focus on eradicating the disease in a remote area containing 250,000 people. The Centre employs Home-Base Care workers, Counselors, Adult/Youth Awareness educators and a Children Program Director. Recent work includes conducting Community Dialogue Sessions encouraging the whole community to take responsibility in the efforts. HIIIA supports MFCC financially and with volunteer teams, including Board Members, to provide specific services.

Tabitha Ministries - Pietermaritzburg, S. Africa

Tabitha operates two Orphanages in the AIDS epicenter of the world. Estimates show that 50% of the local population is HIV positive. Tabitha employs 13 Home Based Care workers who look after 1200 AIDS clients. In addition, Tabitha provides 13 "Mobile Moms" who work with 6000 AIDS Orphans. They teach AIDS awareness to all who will listen. HIIIA supports Tabitha financially and with volunteer teams for special needs. HIIIA Board Members visit Tabitha on an annual basis.
