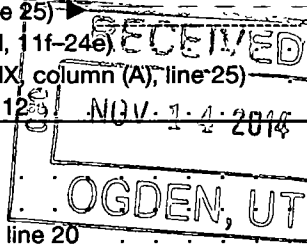

Expenses noted on this Form 990 for Cloud Ridge Publishing are for 2013 only.

**4.** Cloud Ridge Naturalists offered 3 educational seminars to the general public in 2013. Seminars continued to focus on terrestrial and marine ecosystems, with special emphasis on conservation issues associated with global climate change, evolutionary biology and adaptation, the impacts of pollution and general ecosystem health on marine systems, and the natural history of global ocean and nearshore environments. Our seminars provide the finest natural history education experiences available and highlight leading-edge environmental issues and research. The total number of participants in 2013 was 40. Our web brochure ([www.cloudridge.org](http://www.cloudridge.org)) describes the seminar offerings.
