This grant is to the Ophthalmology group operating in concert with The Childrens Hospital, also located on the same campus where RMLEI is located. Our Foundation, in 2011, committed to fund \$40,000 annually for four years which provides a portion of the cost of supporting the Fellowship program at The Childrens Hospital and the related Pediatric Research program being conducted at Childrens.

The \$841 amount is for the examination fees paid by our Foundation for indigent patients treated in the Low Vision Program being conducted at the RMLEI. Included in that amount is reimbursement of travel costs for qualifying indigent patients from more remote locations who may not have otherwise been able to visit the doctors for examination or treatment.
