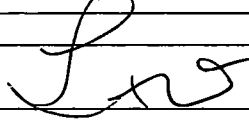

Placement of Children: In 2013, 390 Orphaned children(14 and under) from the People's Republic of China, Haiti, and the US were placed in American adoptive families homes. An additional 332 families had applied and were in the various stages of the pre-adoption process at the end of the year. On 12/31/2013 there were 1,302 families in the adoption process and 1004 Children in post adoption.

4b (Code:) (Expenses \$ 672,210 including grants of \$) (Revenue \$ 565,911)

Childrens Charity Fund: a restricted fund dedicated to the humanitarian assistance to orphanages. The fund has been used to purchase food, clothing, diapers, educational materials, toys, and medical assistance. The Childrens Charity Fund sponsors over 800 children awaiting adoption in the Foster Care programs, Orphanages and the 7 Lily Orphan Care Centers the Henan Province of China.

4c (Code:) (Expenses \$ 335,866 including grants of \$) (Revenue \$ 221,207)

Family Development Services: To ensure the success of the adoption, CCAI developed post adoptions services designed to assist families with the bonding process, cultural and interracial differences. The Joyous Chinese Cultural Center conducts programs for pre-school through elementary school to teach Chinese traditions and to overcome issues associated with adoption. In 2013 several new program for middle and high school students were implemented. Including an Adoptee giving back program, where the teenagers spend several weeks assisting the staff in the Chinese Orphanages.
