Janus Charity Challenge Through the Years

2001 Janus launches the Janus Charity Challenge in partnership with three Ironman races. This unique race-to-raise program supports athletes in fundraising for the charity of their choice as they compete for an additional charity prize purse from Janus for top fundraisers. In the first year, 57 athletes raised \$500,695.00 for 40 different charities.

2002 Participation more than doubles in just one year, with total donations reaching over \$1.6 million.

2003 The Janus Charity Challenge has its first million dollar race, hitting \$1,029,388.25 at the Ironman World Championship in Kona.

2006 The first time a single athlete breaks a million dollars in fundraising – Brad Henderson raises \$1,028,050 at the Ironman World Championships for Leadership Foundations of America.

2007 JCC athletes raise over \$8.5 million for charity at 7 Ironman races – the highest amount in the history of the program.

2010 Janus Charity Challenge participation hits the all-time record of 384 athletes raising money for 324 different charities.

2011 Janus partners with the Life Time Triathlon series, offering the Janus Charity Challenge at races in Austin, Minneapolis, Chicago, Los Angeles and Dallas.

2012 Anana Leuterman becomes the youngest Janus Charity Challenge athlete, raising over \$35,000 for a school for homeless children.

Jim Yanoschik registers for his 10th Janus Charity Challenge race. By 2013, he will have raised \$6,228,672.04 for charities including Rotoplast International, Children's Health International Projects, Canine Support Teams and the Salvation Army - Mervyn's / JC Penney ChildSpree - making him the top fundraiser in the history of the program.

2013 Inspired athletes who have taken the Janus Charity Challenge have raised over \$55 million for 1,356 charities across the globe.
