Powerhouse expansion - The Durango Discovery Museum completed (during 2011) the Phase 1 development of the historic 1893 Durango Power Plant into an interactive Science Museum for all ages It is listed on the National Register of Historic Places This previously blighted downtown riverfront property had hazardous waste and access issues and had been vacant for 27 years There are several planned future initiatives for the site that will occur as funding permits The site has already reconnected the city's historic retail district with the riverfront and the Animas River Trail Powerhouse operations and maintenance This category of expenses represents ongoing operating costs and maintenance of a non-educational nature, but which still indirectly benefit all users
