Assisted Colorado's ranchers and farmers in protecting their agricultural lands and encouraged continuing agricultural production by providing education, acceptance, and monitoring of conservation easements. The organization also consults with governmental agencies and others in the area of land conservation. CCALT had another solid year for land conservation in 2013, protecting more than 21,716 acres in 12 total transactions. More important than the numbers is the positive impact our work is having in protecting rural communities, our ranching heritage and the spectacular working landscapes for which Colorado is known. The Colorado Cattlemen's Agricultural Land Trust takes pride in our 19-year record of fiscal Continued at Schedule Oresponsibility and organizational growth. In 2013, CCALT accepted conservation easements valued over \$14 million. As a non-profit organization, it is critical to be effective stewards of charitable donations and public conservation funding. CCALT prides itself on our fiscal conservatism and our return on investment. In 2013, CCALT protected conservation easements on an operating budget of \$683,000. CCALT has protected over 423,561 acres from 1995 to 2013. We are proud of this accomplishment and are thankful for the generous support of our landowners and donors.

| Part II, Line 5  | The Colorado Cattlemen's Agricultural Land Trust (CCALT) is currently operating under a conservation easement stewardship, monitoring, and enforcement policy originally approved by the board in 1999 and renewed in 2010. Our policies ensure that CCALT will have the financial means necessary to continue our perpetual obligations to steward the conservation easements we have and will accept going forward. CCALT's policies also ensure that CCALT will have the necessary documentation to enforce each conservation easement going forward. This includes accurate baseline files as well as proper documentations of stewardship issues which have occurred in the past. Landowner requests for interpretation or changes to the deed of easement must come in writing. So CCALT has records of the landowner's intentions if a reserved right is exercised, this too must be in writing and in compliance with the notice provisions set forth in each deed of conservation easement. If a property changes hands, it is CCALT's policy to update our records and meet with the new landowner to ensure they fully understand the restrictions set forth on their property. This is to try to prevent future stewardship issues from arising. CCALT has a policy of monitoring every easement on an annual basis. This usually includes a visit to the property in person but may also include aerial monitoring, or remote monitoring. CCALT's conflict of interest policy applies to the stewardship policy and no landowner may monitor their own property. Monitors of CCALT conservation easements will not make decisions in the field as to whether or not a situation is or is not a violation of the terms and conditions of the conservation easement. Instead, monitors will collect information on the item of concern. The upper level staff will evaluate the infraction. If it is determined that the infraction is a violation, the board and legal counsel are notified and a course of action is set to correct the violation. It is the stated policy of CCALT to enforce all of the terms of our conservation easements. With that being stated, it is also the intention of the organization to avoid litigation, if possible, in the enforcement of any violation of a conservation easement. However, legal action may be required and any legal action, including the filing of injunctions, on the part of CCALT requires the adoption of a resolution of the board of directors. |
| Part II, Line 9  | The organization receives gifts of conservation easements, which represent numerous restrictions over the use and development of land not owned by the organization. The donated value of conservation easements is recorded, based on the appraised value as determined by an independent appraiser. The organization's policy for conservation easements is that the benefits flow through to the general public.
