The Tibetan Children's Education Foundation is a nonprofit corporation founded in 1995 and dedicated to the preservation of Tibetan culture by supporting Tibetan schools and school children in exile from their homeland.

Description of Achievements in Carrying Organization's Exempt Purpose

Cultural Tour 2013

One of the major aims of our Foundation is to help preserve Tibetan culture by raising awareness of this unique culture here in the West. Towards this end, the foundation invites Tibetan cultural ambassadors to share their art and culture with interested audiences here in America. We also hope to take interested persons from here to share Tibetan and Buddhist culture sites in India.

This year we continued our efforts to keep Tibet and the Tibetan culture in people's consciousness by undertaking another sand mandala tour. In what could possibly be the last tour by the Venerable Ngawang Chojor, for 2013 we did the following sand mandala events:

Los Gatos, CA - January 2013

Auburn, CA - January 2013

Walla Walla, WA - May 2013

Seattle, WA - June 2013

At most venues, apart from the sand mandala construction, the events included lectures, panel discussions, exhibitions of Tibetan thangkas and screening of Tibetan films. In November 2013, we did a major Tibetan performance concert event in Helena, MT with Tsering Lodoe, a talented young Tibetan performance artist who recently moved to Montana.

Major expenses for this year's cultural tour included travel, boarding, lodging for the artists and accompanying staff during the tour. Major income from the tour came from donations to our general fund and funds for the sponsorship programs.

Children's Sponsorship Programs

Kyitsel-ling Sponsorship Program: Individual sponsors contribute \$25 to \$45 a month to support the education of needy Tibetan children staying at Kyitsel-ling Tibetan Children's Education Center in India. Kyitsel-ling provides board, lodging and meets all school related expenses with this sponsorship money.

Kyitsel-ling Outreach Sponsorship Program: Individual sponsors contribute \$25 to \$45 a month to support the education of needy Tibetan children outside Kyitsel-ling that are supervised by Kyitsel-ling.

For the children's sponsorship program, this year we continued our collaborations with the Department of Education, Central Tibetan Administration (CTA) Dharamsala, India. Operating on our previous model, sponsors contribute \$35 to \$45 a month to sponsor Tibetan children through the Tibetan Children's Education & Welfare Fund (TCEWF) under the CTA and also through Sambhota Tibetan Schools Society, Dharamsala, India, that runs many of the key Tibetan schools in exile in India.

College Sponsorship Program: Many of the children who received their school education through our sponsorship program are now graduating high school. The TCEF board decided to make efforts to support the college education of some of these deserving and needy children. The beneficiary of this sponsorship was again selected by a selection committee headed by the Director of Kyitsel-ling Tibetan Children's Education Center, N. India based on merit and need. Sponsors contribute between \$800 and \$1,080 a year to sponsor the college education of Tibetan children in need.

This year's College Sponsorship Program included our first student here in the United States. Lhamo (Ying Fu) is currently studying at Carroll College, Helena, MT and TCEF in collaboration with another non-profit called A Hundred Friends is sponsoring her education.

Grandparent's Fund:

Living stipends for Elderly: This is an effort to help elderly Tibetans living in exile (mostly in India) in need - those who are sick, those with no children or other family members to provide for them, etc. Individual sponsors contribute \$25 to \$35 a month to support these elders in need.

Other Programs:

English Language Acquisition Project, Dharamasla, India

This is an important project being done in collaboration with the Tibetan Department of Education under the Central Tibetan Administration, in exile, Dharamsala, North India. This project envisages an expert in English language acquisition giving professional development training to Tibetan teachers who teach English Language in the Tibetan schools in exile. This training will include the most current and best practices of English Language acquisition based on research.

An important phase of the project included a field study trip by Sara Buckerfield, Education Consultant and expert in Language Acquisition, and Valerie Hellermann, TCEF Project Manager to select Tibetan schools in exile to study current practices and trends in Tibetan schools. This study will help Sara Buckerfield develop a custom professional training workshop for Tibetan teachers early in 2014.

Lunch Program, Yuksom Sikkim

Dubdi Monastic School is located in Yuksom Village western Sikkim, India. TCEF began a lunch program for this small monastic school in 2008. There are between 24-30 young monks from very poor families receiving their education here. This monastic school is a one room schoolhouse with no electricity and no heat. There are few books that are shared among all the children and each child has only one thin notebook and they use their pencils down to tiny stubs. The lunch project for the monks in Yuksom continued in 2013.

Sikkim Computer Project:

In Sikkim, we partner with Sukhavati Educational Hostel, to help provide education access to needy children of Tibetan, Nepali and Indian origin in this remote location. In 2013, the TCEF Service Trip included procuring 11 computers (with related software and paraphernalia), having them installed and procuring a Computer Education teacher for the children. We believe that Computer Education is an important part of the education of these children and that it will help them to ultimately find employment and be comfortable and competitive in this modern world.

TCEF Service Trip Programs 2013

TCEF invites interested individuals with skills to teach and empower those we serve on yearly Service Trips. These trips go to the TCEF service sites in India and do hands on projects. The service trip fee includes the cost of the projects selected that year and the cost of ALL in country transportation, food and lodging.

This year the Service trip began in Dharamsala India. There we met with Lobsang Sangay, The Prime Minister, Trinley Palmo, the Deputy Director of Public Health from the Central Tibetan Administration and members of Tibet Charity to discuss how best to serve the Tibetan community in exile. While in Dharamsala we visited the Elder Khang (old age home) and distributed socks, basic medicines and fruits to the elders.

We continued on to our main service sites in Sikkim, the Dubdi Monastery and the Sukhavati Hostel. Our main focus was to perform basic health assessments, including eye and hearing testing, provide basic medications and instructions, gave deworming medications and referred more complex medical issues to the district hospital. We visited the district hospital with a patient and renewed our relationship with Dr. Bhutia.

We also purchased computers for the Sukhavati Hostel and hired a computer instructor. There were several teachers on the trip who provided educational material, instructions and children's books.

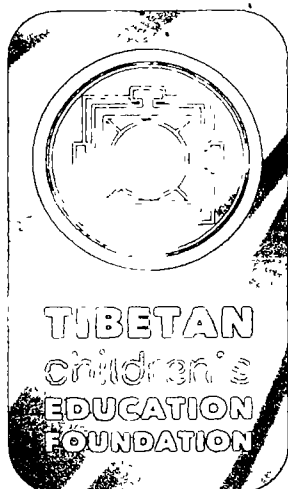
