IN 2013 MOGA BIG HEARTS UNDER THE BIG SKY (BHUBS) PROGRAM PROVIDED 8 ADVENTURE/TRIPS TO OUR PARTNERS. THREE WERE GRANTED TO CATCH-A-DREAM FOUNDATION, TWO TO THE WOUNDED WARRIOR PROJECT, ONE TO CASTING FOR RECOVERY (SERVED 25 PEOPLE), ONW WAS DONE INDEPENDENTLY AND ONE TO GRATEFUL NATION. IN SO DOING WE WERE ABLE TO FULLY MEET THE REQUESTS OF ALL FOUR OF OUR NATIONAL PARTNERS. THESE ADVENTURE/TRIPS SERVED 56 PEOPLE AND TOTALED \$59,384 IN DONATED RETAIL VALUE. BHUBS PAID OUT \$27,766 TO PARTICIPATING OUTFITTERS TO COVER 47% OF THEIR COSTS SINCE 2008, BHUBS HAS SERVED 39 FAMILIES/GROUPS TOTALING 264 PEOPLE, INVOLVING 24 OUTFITTER BUSINESSES AND ACCOUNTING FOR \$264,748 IN DONTATED ADVENTURES. IN 2014 WE EXPECT THE DEMAND FOR THE PROGRAM TO GROW SUBSTANTIALLY AS WE WORK TO SERVE THE NEEDS OF OUR NATIONAL PARTNERS. THE GROWTH WILL BE PARTICULARLY EVIDENT IN THE SERVICE OF MILITARY VETERANS AND THEIR FAMILIES.
