- In 2013 we completed our PCMH Foundations program funded by the Colorado Health Foundation (TCHF), achieving all seven strategic milestones outlined in our grant application.
- We provided more than 639,000 patients with access to evidence-based clinical care through a registry functionality to support chronic conditions and improve prevention.
- We supported more than 213 practices over four years through practice coaching and rapid improvement activities.
- Engaged participating practices at local Learning Collaboratives with an average of 146 participants from 47 practices with an 88 percent participation rate.

Comprehensive Primary Care initiative (CPCi)

- HealthTeamWorks continues to provide practice transformation coaching to more than 60 of the 73 practices across Colorado participating in the Centers for Medicare and Medicaid Services CPCi initiative.

Colorado Family Medicine Residency PCMH Project

- HealthTeamWorks residency program worked with every residency program in the state of Colorado throughout all of 2013, teaching the PCMH model of care to the next generation of physicians and staff.
- Work for this initiative was recognized in the *Family Medicine* and was presented at the Society of Teachers of Family Medicine Annual Conference on Practice Improvement.

Reach in Colorado and Beyond!

- HealthTeamWorks remained involved in the monthly meetings and practice transformation with three Regional Extension Centers (RECs).
- Our CEO, Dr. Marjie Harbrecht, gave more than 35 presentations in cities across the country to explain the patient-centered medical home (PCMH) model of care and inspire payment reform, patient engagement and integrated communities of care.
- Our members of our team participated in more than 15 national conferences to promote our mission-driven work, the PCMH model of care, evidence-based care and patient engagement.
