The Native Science Field Centers (NSFC) offer year-round environmental science field programs that integrate traditional ways of knowing Native language and Western science methods. There is currently one year-round Native Science Field Center on the Blackfeet Reservation in collaboration with Blackfeet Community College. A local director and Community Advisory Board administer this Center. The Blackfeet NSFC engage youth and adults in outdoor science and cultural programs to encourage their long-term involvement with their environment with support from the National Science Foundation. 200 youth and adults were served in this program.

4b (Code:) (Expenses \$ 80,783. including grants of \$ 10,650.) (Revenue \$ 0.)Strengthening the Circle South Dakota (STC):

Strengthening the Circle is a Native nonprofit leadership program that is designed to: (1) expand year-round capacity-building training and technical assistance services to Native nonprofits focusing on education and asset development; (2) provide Native nonprofit leaders with organizational development assistance to establish strategic plans and procedures for measuring progress and improving performance towards intended outcomes leading to community impact; (3) develop culturally appropriate training materials; and (4) invite foundation participation in STC and Native community-based initiatives to support and sustain this work. Forty-five Native nonprofit leaders were served through this program in 2013.

4c (Code:) (Expenses \$ 174,760. including grants of \$ 0.) (Revenue \$ 0.)Hopa Mountain's StoryMakers Program:

Hopa Mountain's StoryMakers program is an early learning initiative that offers parents of children ages 0-5 proven tools to support them in creating a home environment that gives their children the best chances for success in school and life. Through community teams of citizen leaders, the StoryMakers program offers: high-quality, age and culturally-appropriate, children's books as tools to enhance children's social, emotional and cognitive development; current parent-friendly child development information and book-sharing ideas; personal encouragement to shape home life for children's success with relationships and learning. This program is made possible through generous support from the W.K. Kellogg Foundation, the M.J. Murdock Charitable Trust, the Paul G.
