PRMC Auxiliary operates a gift shop in the hospital. Merchandise includes gift nitem, snacks and sundries. The gift shop is open to the public, to hospital patrons and to hospital staff 358 days per year from 9:00 AM to 4:00 PM six days each week. It is estimated that 30 to 50 individuals come into the gift shop each day to make purchases or to browse.

4b (Code:) (Expenses \$ 19000 including grants of \$) (Revenue \$ 0)

PRMC Auxiliary provides scholarships to area medical students. There are an estimated 15 to 20 scholarships awarded each year in the amount of \$1000 for full time students and \$500 for part-time students.

4c (Code:) (Expenses \$ 1186 including grants of \$) (Revenue \$ 0)

The auxiliary provides assistance to PRMC through service at the information, at the cancer center, at the rehab center, at the surgery center and any other area as needed. Approximately 35,000 clients, patients and staff are served through volunteer staffing by the auxiliary. Volunteers give direction to hospital services, direct visitors to patient rooms, work in the gift shop.
