Summary of 2013 Program Accomplishments

The New Mexico Acequia Association had a successful year in working toward our mission of protecting water and acequias, growing healthy food for our families and communities, honoring our cultural heritage. NMAA built upon our education and outreach work in the areas of water rights protection and agricultural revitalization through our Land and Water Program, our Food and Agriculture Program, and our Farmer-Rancher Outreach Program. We also continued to expand the scope and effect of our Organizing and Leadership Development Program by enhancing our Escuela de las Acequias leadership development program and expanding our intergenerational youth and family program, Sembrando Semillas Land and Water Program. The purpose of the Land and Water Program is to protect the water rights and agricultural lands of acequia communities by strengthening the capacity of acequias and community ditches to protect historic acequia water rights and to manage water for the benefit of their respective communities. Our primary area of focus in this program is the Acequia Governance Project, through which NMAA does much of its workshop outreach and technical assistance. This project utilizes a culturally appropriate approach to community education. This includes one-on-one technical assistance and community-based workshops in addition to creating educational materials that are updated annually based on lessons learned in the field. In addition, the Mayordomo Project has developed a DVD film and curriculum to support the education and mentorship of new mayordomos. Another emerging area of work under this program is our Acequia Restoration and Resiliency Plan pilot project that focused on the infrastructure needs, farm succession, agricultural trends, and the preservation of farmland and water rights of one acequia within the acequia community of Dixon, NM Acequia Governance Project. The purpose of the Acequia Governance Project is to strengthen local water management by acequias through community education and specialized technical assistance. The topics that are covered in workshops and one-on-one consultations include water rights, New Mexico water law, acequia easements, elections, Open Meetings Act, Inspection of Public Records Act, the Audit Rule, and enforcement powers of acequias. NMAA held 24 workshops, including 2 statewide workshops and 5 regional workshops to address acequia governance topics, with a total of over 1443 attendees. Presented at over 31 acequia meetings throughout the state, with a total of over 506 attendees. Provided 317 instances of technical assistance to acequias throughout the state. Assisted 14 acequias throughout the state with completion of new bylaws/Infrastructure Planning. The NMAA provides assistance to acequias in creating infrastructure capital improvement plans (ICIPs) that establish planning priorities for anticipated capital projects. The plan covers a 5-year period and is developed annually. It includes policy direction, funding time frames, estimated costs, justifications and the details of each specific infrastructure capital improvement project proposed, by year, over the five-year period. In 2013, 23 ICIPs were completed with assistance from the NMAA for acequias throughout the state. Mayordomo Project - The purpose of the Mayordomo Project is to support the training and recruitment of individuals with the knowledge and capacity to serve as mayordomos for acequias. The mayordomo is the person elected from within an acequia community to serve as the caretaker and manager of the ditch in terms of the irrigation schedule and ditch maintenance. The role of the mayordomo is essential to the practice of acequia irrigation and the attrition of elders serving as mayordomos is a major concern, as is the loss of knowledge needed to manage and maintain the ditches. In 2013, the video entitled The Art of Mayordomia, was successfully copyrighted by NMAA, and disseminated as a community education toolkit that included the DVD film, the Mayordomia Handbook and Field Guide, along with a set of community questions to evoke engaged discussions within acequia communities, colleges, and schools. The Mayordomia Handbook and Field Guide, documents the method, seasonal tasks, and wisdom of mayordomos and is meant to serve as a practical guide for acequias. This handbook was also disseminated in 2013 as a stand-alone guide. Acequia Restoration and Resiliency Plan - In 2013, NMAA piloted a proactive planning model for acequias, the Acequia Restoration & Resiliency Plan (ARRP), for the Acequia de la Plaza de Dixon in Rio Arriba County. The project was born out of strategic planning discussions about the need for comprehensive assessments, and planning for acequias, before crisis situations arise. The purpose of the ARRP is to strengthen, revitalize, and build capacity of the acequia by engaging its community leaders in planning for the future of their acequia. The plan provides informative data and tools to the Acequia to assist in the preparation of funding requests for infrastructure improvements, and as a method for asserting self-determination as a historical, self-governing entity that uses community input to address challenges. The research for the plan was still ongoing at the end of 2013. Food and Agriculture Program - The Food and Agriculture Program supports the work of the Sembrando Semillas Project, the purpose of which is to cultivate the next generation of farmers and ranchers through intergenerational community food projects. The program also includes the NM Food and Seed Sovereignty Alliance, a collaborative acequia-Pueblo alliance established to promote the cultivation of native seeds and to protect the seeds from genetic contamination. Sembrando Semillas Project - The NMAA supported community garden projects in three communities in 2013. Chamisal. This site continued as the primary hub for the Sembrando Semillas project. Over 16 youth participated in a series of hands-on workshops and community garden activities geared toward learning agricultural traditions with a mentor, Edward Gonzales, who is also working with American Friends Service Committee as a farmer trainer. Thirteen of these youth also participated in NMAA's leadership training program, the Escuela de las Acequias. Mora. Mora acequia leaders conducted an intergenerational Family and Community Gardening Project that engaged a group of 14 adults and 12 youth from local families in growing gardens and learning about food traditions. The site provided six workshops culminating with a harvest celebration and meal. Alcalde & Penasco. In 2013, NMAA also sponsored a FoodCorps Service Member who provided bi-weekly curriculum activities to over 100 students, on the theme of growing healthy food and healthy diet choices to elementary and middle school students in the Penasco Independent School District, as well as the La Tierra Montessori School of Alcalde, where NMAA staff assisted in the development of a community garden project and workshops for students and their families. Because of the connection to FoodCorps, NMAA also hosted a three-day NM FoodCorps training in June 2013 for 22 state and national FoodCorps service members, educating members on the unique issues pertaining to acequia agriculture. NM Food and Seed Sovereignty Alliance - During 2013, acequia and native youth and families participated in the annual Owingeh, Taos, Pueblos y Semillas Gathering and Seed Exchange on April 7, 2013, with over 151 total participants, including 82 youth. The event was hosted by the New Mexico Food and Seed Sovereignty Alliance, a collaboration of NMAA and the Traditional Native American Farmers Association, Tewa Women United, and Honor Our Pueblo Existence. The event is instrumental in building an advocacy support base for traditional foods, traditional agricultural methods, and protection for heirloom (non-GMO) seed varieties specific to the region. The event also encouraged a renewed paradigm of community health, based on food security provided by increased access to healthy, fresh, locally grown food. Farmer-Rancher Outreach Program - The Farmer-Rancher Outreach Program was funded in 2013 by the USDA Outreach and Socially Disadvantaged Farmers and Ranchers (OSDFR) competitive grant program. NMAA staff provided technical assistance for farmers and ranchers, held workshops, and aided in and facilitated the creation of farm plans, conservation plans, and USDA applications. NMAA staff presented at three statewide agricultural workshops in Santa Fe with a total of 310 attendees. Coordinated and presented at 8 county, multi-county, and regional workshops with a total of 436 attendees, in the counties of Rio Arriba, Mora, San Miguel, Santa Fe, Sandoval, Bernalillo, and Taos. Presented at 10 acequia meetings to 252 participants on various USDA programs. Provided individualized technical assistance to 346 individuals throughout the state.
