In order to remain in good standing they must complete 12 or 9 credits respectively with at least a 2.0 GPA. Working students are those who are working in the Norton Sound Region. These students are funded based on the amount of credits they are taking. Because they are a working student, they do not need to take classes full-time and there is no deadline for those students. All of the guidelines except the deadline need to be met by the working students before they are funded.
