Healthcare - Africa Foundation (USA) builds and upgrades clinics and accommodations for medical staff. In 2013, a new wing was built for the Mduku clinic in KwaZulu Natal, South Africa. The clinic provides 24-hour care to Mduku and surrounding communities located within 30 kilometers. The new wing allowed for the separation of patients with serious and contagious diseases from those with less serious ailments. It also allowed for the separation of women and children, providing them with safety and privacy.

4b (Code:) (Expenses \$ 176,835 including grants of \$ 176,835) (Revenue \$)

Education - Africa Foundation (USA) makes the building and improvement of preschools primary schools, and high schools a priority believing that through education, rural people can break the cycle of poverty. Projects sites included: South Africa (\$53,949), Tanzania (\$60,381), Botswana (\$36,000) Africa Foundation (USA) also helped fund the Community Leaders Education Fund (CLEF) (\$26,505). This bursary program has a primary goal to empower communities by building leadership and enabling individuals to realize their dreams. The program has two components, the academic sponsorship and the requirement of the recipient that they share their newly acquired knowledge and skills with their communities by performing meaningful tasks that benefit the community.
