MONTHS LATER, MICHAEL WAS NOT COMPENSATED FOR HIS LOST TIME. CONSEQUENTLY, MICHAEL SUBMITTED A REQUEST TO CASH OUT HIS PAID TIME OFF FROM HIS EMPLOYER (UMC). AS A RESULT, UMC PAID MICHAEL \$5,083.32 IN COMPENSATION.

SUBSEQUENTLY, MICHAEL RECEIVED A CHECK FROM THE INTERNATIONAL FOR HIS LOST TIME WAGES. MICHAEL WAS UNDER THE IMPRESSION THAT THE COMPENSATION HE RECEIVED FROM UMC WAS A CASH OUT OF HIS PAID TIME OFF WHILE UMC WAS UNDER THE IMPRESSION THAT THE COMPENSATION PAID WAS FOR LOST TIME.

UMC REQUESTED THAT THE COMPENSATION PAID TO MICHAEL AS LOST TIME BE REIMBURSED BY THE LOCAL. THE LOCAL INITIALLY DID NOT PAY UMC AS UMC SHOULD NOT HAVE PAID MICHAEL LOST TIME WAGES. MICHAEL WAS NOTIFIED BY UMC THAT HE WOULD BE TERMINATED IF THE LOST TIME WAS NOT REIMBURSED. FACING TERMINATION OF EMPLOYMENT, THE LOCAL REIMBURSED UMC THE LOST TIME AND ISSUED A LOAN TO MICHAEL FOR \$5,083.32 DURING MARCH 2013.
