Puresa Humanitarian is dedicated to providing rescue, hope, and a way out of slavery for children and women, victims and survivors of human trafficking and sexual slavery Puresa Humanitarian has now expanded its work from Nepal into India reaching and rescuing both Indian and Nepali children and women who are trapped in trafficking situations throughout the city, in brothels, remote villages, borders of its neighboring Nepal through which 15,000+ young girls are sold and lost into India yearly Puresa Humanitarian has established work in this region where so many children, teens, and young women are easy targets for human traffickers, areas where few risk entering in order to rescue victims, give healing support and create new pathways in life for them Puresa Humanitarian has now accomplished expanding its rescue work directly into the brothels of India where thousands of women and children are trapped and desperately need help, we have achieved holding medical outreach within the brothels and have brought medical care to the many abused and trapped women and children in the brothels who are in deplorable health and in need of medical care We have been able to rescue many young children as young as 3, 4, and 5 years old out of the brothels and these children are now living within our safe home As we have seen the urgency and atrocity of so many children trapped inside of the brothels being exploited, we have opened a safe home for children in India We have also accomplished rescuing many of the children's mothers and we continue providing skills training and opportunity for the rescued women which creates self-sustainability and opportunity for a future of independence and helps her to earn so she can help herself and her family escape poverty, helping to break the cycle of human exploitation and sexual slavery We continue with a passion providing rescue, safe homes, education, medical care, food, counseling, complete aftercare and prevention programs on the field throughout areas where so many are at risk of being trafficked, bringing help and healing to these innocent victims and empowering them, being part of the solution to empower the survivors to have a new life and have the potential to escape poverty and change their world
