THEY WERE ABLE TO GIVE GROCERIES, TOILETRIES, AND OTHER ASSISTANCE TO NEARLY 7,000 INDIVIDUALS, MANY OF WHOM RECEIVED ASSISTANCE MONTHLY. OVER 39,000 CASES OF FOOD AND DRINK PLUS ALMOST 95,000 POUNDS OF PRODUCE WERE DISTRIBUTED THROUGHOUT THE YEAR TO THE INDIGENT POPULATION IN SAN JOAQUIN COUNTY.
