Medical Services: Mt. Baker Planned Parenthood (MBPP) provides comprehensive reproductive health care for women and men. Services include birth control method counseling services and supplies; pregnancy testing and option counseling, first-trimester abortion care, education, and support; referrals for prenatal care, parenting, adoption; annual checkups, pap smear, breast and pelvic exams; testing and treatment of sexually transmitted diseases; colposcopy and LEEP services; vasectomy and post-vasectomy exams and testing and health education.

Mt. Baker Planned Parenthood provided 53,687 preventive and essential medical services to 10,900 clients. In 2013, or health centers

Community Education: Mt. Baker Planned Parenthood (MBPP) offers educational programs free to public schools and other social service agencies. Our Health Educators are dedicated to providing quality programs and frequently work closely with teachers and program coordinators to design presentations that are customized to a specific classroom or group.

In 2013, MBPP educators offered 436 educational programs that reached 6,388 participants.

Public Affairs: The Public Affairs Department provides information, support, and training that helps Mt. Baker Planned Parenthood (MBPP) supporters influence public policy and legislative processes. MBPP works with local, state, and national officials and through public-information and grassroots organizing to make sure that reproductive health care is recognized as a basic and fundamental health-care service; improve access to family planning services; improve the availability and accuracy of sexuality education in public schools; keep abortion safe and legal; and reduce teen pregnancy rates in Washington.
