in contract to provide those services and looking at fringe benefits and whether other agencies are offering comparable benefits or not. The  
Executive Director and agency Bookkeeper make a pay scale recommendation to the Finance Committee of the Board of Directors. The  
Finance Committee then studies the information and recommends to the full Board of Directors where the final approval comes from. The  
Executive Directors pay is determined by a like position and job description comparison performed by the Board of Directors. Any changes  
to the Executive Directors pay and/or benefits is discussed and voted on by the full Board. It is agency procedure that no change may be  
made without written approval from the Board of Directors.
