Providence St Peter Hospital offers a wide range of services that provide health benefits to the uninsured and underserved in Southwest Washington community These services, most of which do not generate enough income to support themselves, include programs such as psychiatry, chemical dependency, a sexual assault clinic, and a pediatrics division, free and low-cost health screenings and education events, support services for cancer patients, survivors and their families, and medical training, research and career development for current and future medical professionals Providence St Peter Foundation supports these services by developing and receiving philanthropic resources from the generous individuals and businesses within the community In 2013, with these donations, the Foundation was able to provide over \$300,000 to fund the acquisition and upgrade of such necessary equipment as vital sign monitors, ultrasounds, patient lifts, pediatric cribs and a security door system for the Hospital's emergency department The Foundation was also able to provide over \$100,000 to fund psychiatric resources and services, animal-assisted therapy, assistance to employees facing financial hardships and bedside companionship and grief counseling for dying patients and their families The Foundation also funded over \$90,000 in continuing education and medical training activities for palliative care and hospice professionals, nurses and nurse technicians, and other medical personnel The Foundation also supported various improvements throughout the hospital, such as the purchase of new furniture, exercise and physical rehabilitation equipment, maternity supplies and towels, sweatshirts and sweatpants for patients

The population of Thurston County has grown by 22% over the last ten years Providence St Peter Hospital has seen admissions grow at a similar rate Thurston County has been one of the fastest growing counties in Washington State Due to population trends, PSPH can no longer accommodate the demand for in-patient admissions This means local residents are traveling greater distances to have medical care Beginning in 2011, Hospital leadership addressed the issue by implementing a patient bed expansion plan that added an additional 21-beds and associated infrastructure The expansion project will benefit the entire hospital as these beds can be used for many levels of care The project funding comes from a variety of sources including, debt financing, hospital operating budgets, and generous philanthropic support from the community

Profits from the gift shops at Providence St Peter Hospital that are donated to the Foundation are awarded back to the Hospital through an annual grant cycle coordinated by the Volunteer Services Director, a committee of volunteers and assistant administrator Through these funds in 2013, the Foundation was able to support the Hospital's purchase of equipment for pediatric & infant respiratory support, intubation and spine surgery

Providence Sound HomeCare and Hospice brings the Providence tradition of excellence into the home setting Their goal is to provide the highest level of service in a caring and responsive manner The home care and hospice teams work together with physicians, patients, family members and insurance providers to meet each patient's unique needs Access to its professional services is available 24 hours a day, every day Serving Mason, Lewis and Thurston counties, Providence Sound Homecare and Hospice is a non-profit, state licensed and Medicare certified agency Foundation funding helps with respite care, comfort therapies, gnef support, and education

The Sexual Assault Clinic is part of Providence St Peter Hospital in Olympia It serves residents of Thurston, Lewis, Mason, Grays Harbor, Pacific and Wahkiakum counties The physicians, nurse practitioners, nurses and social workers provided special medical evaluations for children, adolescents and adults Patients and their families are then referred to community agencies for counseling and other services The Sexual Assault Clinic is a certified specialty services provider The Washington State Crime Victims Compensation Program pays for some of the associated expenses for the medical evaluation Patients or their families will not be charged Victims of an assault that occurred within the last 96 hours should be seen at a hospital emergency room The sexual assault nurse examiners are on call to the Providence St Peter Hospital emergency room

In 2013, the Foundation provided support to the Sea Mar Community Health Center's extended-hours walk-in clinic in Olympia This clinic specializes in family medicine and delivers a wide range of acute, chronic, preventive and internal medicine services Funding from the Foundation provided the clinic with digital x-ray equipment

Providence Mother Joseph Care Center (MJCC) is a Catholic, non-profit facility committed to improving the care and quality of life for the elderly and chronically ill MJCC provides high-quality care with an emphasis on respect for the cultural and spiritual diversity of those it serves The employees, volunteers and medical staff recognize the dignity and value of each individual MJCC provides sensitive, holistic care to meet the physical, spiritual, social and psychological needs of each patient

Providence St Peter Chemical Dependency Center has been a chemical dependency provider since 1986 Its staff is committed to helping individuals and families whose lives have been affected by the harmful use of alcohol and other drugs It offers options to diagnose, treat, and provide ongoing recovery support Its medically supervised programs offer excellence in clinical counseling and comprehensive education Its programs are based on the principle that each person's needs are unique, and must be addressed specifically Its treatment model incorporates the nationally recognized American Society of Addiction Medicine (ASAM) placement criteria, family involvement, and community-based recovery support groups In 2013, the Foundation provided funds to this program to support staff training and conferences, educational materials (such as drug cessation books and DVDs) for clients and supplies for the treatment of tobacco and gambling addiction

Providence also maintains a network of community ministry boards with responsibility for quality of care oversight, community relations, advocacy and community needs assessments. Providence has a consistent compensation philosophy for all of its employees, including our senior executives. Salaries for senior executives are determined by the Providence Board's Human Resources Committee and approved by the full Board of Directors, none of whom is a Providence employee. The Board retains an independent consultant each year to review salaries of those in the most significant leadership roles in the organization. Part of the consultant's role is to review an extensive array of compensation surveys of large, not-for-profit health care systems in the United States. Providence is one of the larger health systems in the country, and as such, the Board benchmarks executive compensation against other large, not-for-profit health systems whose revenue is similar to that of Providence. Base salaries for Providence executives are set at the median level of the market, as identified by the independent consultant and reviewed with the Human Resources Committee. Performance incentives allow executives to earn additional compensation if they achieve specific organizational and individual goals for furthering Providence operating principles & advancing the Providence Mission and core values, meeting benchmarks for charity care, achieving quality targets, delivering top-rated customer satisfaction, meeting employee satisfaction goals and reaching financial performance objectives. The Board of Directors conducts a thorough process to ensure performance incentives are aligned with appropriate practices for not-for-profit health care systems. The Board's process for executive compensation fully complies with IRS standards and mirrors the best practices recommended in the "Report to Congress and the Nonprofit Sector on Governance, Transparency, and Accountability" submitted to the Senate Finance Committee by the Panel on the Nonprofit Sector. Applying the above principles, the salary review of the Foundation Executive Director is handled annually through the WA/MT Regional HR office.
