small amounts of money through private donors and small events. No fees are charged by SASG to administer these funds.

No grant requests have been made on their behalf using our agency, tax id, or 501(c)(3) as a pass through. A signed agreement

between Strength Over Speed and SASG defines the terms of this agreement.
