Services are free of charge and available to people who are Deaf, DeafBlind or Hard of Hearing and are residents of King, Pierce or Snohomish County. During 2013, ADWAS served 121 women and 51 children through our Supportive Housing Program, 8,003 as part of our outreach and education program, 1,447 callers to our National DV Hotline Counseling - The counseling program offers victims of domestic violence and sexual assault the following services: 1) Short-term crisis counseling, 2) On-going individual/family therapy related to domestic violence & sexual assault, 3) Group counseling related to childhood sexual assault and domestic violence, 4) Psychosocial assessments and evaluation of sexual abuse of children, 5) Client advocacy and referrals
