	Powerful Choices - Provide adolescent girls with education and pro-social activities to promote positive identity, promote healthy relationships and 21st Century Skills The curriculum is delivered through group and individual seassions Powerful choices was offered at two Seattle Public Schools middle schools and in partnership with Atlantic Street Center in 2013, reaching 67 youth Youth Employment Program - Provides adolescent girls with pre-employment, career building and 21st Century Skills Two cohorts of girls participate in a group employment program that includes individual goal setting and performance evaluation sessions The first cohort is Develop Your Voice and Speak (DYVAS), where young women are employed to produce an alternate form of media to educate the community about social justice issues The second cohort is Active Vistas, where young women are employed to develop and present workshops at the Girlvolution Conference The Youth employment Program served 31 youth in 2013 referred through Seattle Youth Violence Prevention Initiative Case management - Provide individual support to adolescent girls to help them meet their goals of service-learning, employment and education A Case Manager meets regularly with youth to set goals, provide encouragement, support, information and referral services and monitor progress toward accomplishment of goals In 2013, 34 young women received these services They were referred to this program through Seattle Youth Violence Prevention Initiative Community Engagement - Powerful voices works within the community on girls' issues to promote equity and make the world a just place for everyone Community engagement efforts include producing the annual Girlvolution Conference, providing training on Powerful Voices curriculum and practices, serving on coalitions and partnering to provide outreach to girls detained in King County Juvenile Detention In 2013, the Girlvolution Conference reached over 250 youth and adult allies Powerful Voices staff provided training 100 other youth development professionals, and trained and supported 13 new Adult Allies (mentors)and served on three community coalitions Powerful Voices staff facilitated educational and pro-social workshops with 29 young women in detention
